WASHINGTON, D.C. (TIP):

President Donald Trump plans to impose tariffs on Canada and Mexico starting Tuesday, March 4, 2025, in addition to doubling the 10% universal tariff charged on imports from China.

In a Truth Social post Thursday, February 27, Mr. Trump said illicit drugs such as fentanyl are being smuggled into the United States at "unacceptable levels" and that import taxes would force other countries to crack down on the trafficking.

"We cannot allow this scourge to continue to harm the USA, and therefore, until it stops, or is seriously limited, the proposed TARIFFS scheduled to go into effect on MARCH FOURTH will, indeed, go into effect, as scheduled," the Republican President wrote. "China will likewise be charged an additional 10% Tariff on that date."

Former defense chiefs denounce Trump's 'reckless' Pentagon firings

WASHINGTON, D.C. (TIP): Five former defense secretaries on Thursday, February 27, denounced President Donald Trump's firing last week of the Joint Chiefs chairman and several other senior military officials, urging Congress to hold hearings and declaring they have concluded the officers were "fired for purely partisan reasons", says a Washington Post report. The extraordinary public appeal was signed by Lloyd Austin, Jim Mattis, Chuck Hagel, Leon Panetta and William Perry - who served in Republican and Democratic administrations dating back to the 1990s - after Trump's Friday night firings caused an uproar on Capitol Hill and among many military veterans.

SAN FRANCISCO (TIP): A California federal judge on Thursday, February 27, temporarily blocked the Trump administration from ordering the US Department of Defense and other federal agencies to carry out the mass firings of thousands of recently hired employees.

US District Judge William Alsup in San Francisco said during a hearing that the US Office of Personnel Management lacked the power to order federal agencies to fire any workers, including probationary employees who typically have less than a year of experience.

The 1984 anti-Sikh riots remain one of the darkest stains on India's history. The fact that it took 34 years to convict a single leader and that many others died without facing trial is a testament to the failures of the justice system. While the sentencing of Sajjan Kumar provided a small measure of justice, it came far too late for many victims.

The assassination of Prime Minister Indira Gandhi on October 31, 1984, by her Sikh bodyguards, Beant Singh and Satwant Singh, set off a horrific chain of events that led to one of the darkest chapters in India's post-independence history. In the days following her killing, a pogrom was unleashed against the Sikh community in Delhi and other parts of India. Mobs, reportedly orchestrated and incited by political leaders, targeted Sikh homes, businesses, and gurudwaras. More than 3,000 Sikhs were brutally murdered, and thousands more were displaced. The violence, marked by extreme brutality, was widely seen as a state-sponsored massacre.

Despite the scale and nature of the violence, justice remained elusive for the victims and their families for decades. Successive governments failed to take decisive action, and many of those accused, including prominent political leaders, continued to hold positions of power. One such figure was Sajjan Kumar, a senior leader of the Congress Party, who was finally sentenced to life imprisonment in 2018-34 years after the pogrom, and he remained behind bars as the legal system slowly caught up with those responsible. His sentencing was a momentous but long-overdue step, illustrating the maxim that "justice delayed is justice denied."

The anti-Sikh riots that erupted in Delhi and other parts of India from November 1-4, 1984, were not spontaneous acts of mob violence. They were widely believed to be organized, with Congress Party leaders allegedly directing the rioters and police standing by as Sikhs were killed. Eyewitnesses testified that the mobs were armed with voter lists to identify Sikh households. The rioters used petrol, kerosene, and tires to burn Sikh men alive, while women were assaulted and children killed mercilessly.

The violence was most pronounced in Delhi, where over 2,700 Sikhs were killed. Other affected areas included Kanpur, Bokaro, and other parts of Uttar Pradesh, Haryana, Madhya Pradesh, and Bihar. The police were accused of being complicit, either refusing to register complaints or actively supporting the rioters. The central government, led by Rajiv

Gandhi, failed to intervene effectively, with the infamous justification that "when a big tree falls, the earth shakes."

Over the years, multiple commissions and committees were formed to investigate the 1984 anti-Sikh pogrom. However, justice remained elusive due to deliberate delays, political interference, and lack of willpower to hold the powerful accountable. Some of the most prominent inquiries included: **MARWAH COMMISSION (1984):** The first inquiry, led by Ved Marwah, was abruptly stopped by the government before it could complete its report.

**MISRA COMMISSION (1985):** This commission, led by Justice Ranganath Misra, was widely criticized for its bias in favor of the Congress Party. It absolved many top leaders of wrongdoing, further eroding Sikh trust in the system.

**JAIN-BANERJEE COMMITTEE (1987):** This committee recommended the prosecution of several Congress leaders, including Sajjan Kumar, but its findings were ignored.

**POTI-ROSHA COMMITTEE (1990) AND JAIN-AGGARWAL COMMITTEE (1991):** These commissions recommended further investigation but faced obstruction from political forces.

**NANAVATI COMMISSION (2000-2005):** After nearly two decades, this commission confirmed that Congress leaders such as Sajjan Kumar and Jagdish Tytler were involved. However, the government took little action.

**SPECIAL INVESTIGATION TEAM (SIT) (2015):** In 2015, the Narendra Modi government appointed an SIT to reopen cases, leading to the conviction of several perpetrators, including Sajjan Kumar.

Sajjan Kumar, a former Congress MP, was accused of inciting mobs to kill Sikhs in multiple locations in Delhi, including Sultanpuri, Mongolpuri, and other Sikh-dominated areas. Survivors and witnesses testified that he was seen directing the mobs and instructing them to attack Sikh homes and businesses.

Despite overwhelming evidence, he evaded justice for decades due to political patronage and a lack of prosecutorial effort. It was only in December 2018, after sustained pressure from Sikh advocacy groups and the reopening of cases by the SIT, that the Delhi High Court found him

guilty of murder, rioting, and conspiracy. He was sentenced to life imprisonment, a landmark ruling that finally held a senior politician accountable. The judgment noted that the killings were "crimes against humanity" and emphasized the failure of law enforcement agencies in protecting Sikhs.

The 41-year delay in convicting Sajjan Kumar reflects the broader failure of India's legal and political system in delivering justice for the 1984 victims. Many perpetrators, including prominent Congress leaders, never faced trial and died without punishment. Jagdish Tytler, another accused leader, continued to serve in various political capacities despite being named in multiple reports. Similarly, Kamal Nath, who was alleged to have played a role in the violence, went on to become a cabinet minister and Chief Minister of Madhya Pradesh.

For the Sikh community, the 1984 massacre remains an open wound. The lack of timely justice has deepened their sense of alienation and betrayal. Sikhs across the world, particularly in Canada, the UK, and the US, have consistently demanded accountability and recognition of the pogrom as an act of state-sponsored genocide. Many believe that the wounds of 1984 will never heal until every perpetrator is held accountable.

While Sajjan Kumar's conviction was a symbolic victory, it was far from sufficient. Thousands of affected families continue to live with the trauma of 1984, knowing that many of those responsible escaped justice. The episode underscores the importance of independent investigations, judicial reforms, and political accountability to ensure that such massacres never recur.

Sikhs worldwide continue to remember and mourn the events of 1984, keeping the memories alive through protests, literature, and advocacy. The lessons from this tragic chapter serve as a reminder that justice delayed is indeed justice denied. India must ensure that such atrocities are never repeated and that those responsible, regardless of their political stature, are held accountable in a timely manner.

The delayed justice in the 1984 pogrom case raises critical questions about India's legal system and political accountability. It exposes how powerful individuals can manipulate institutions to escape punishment. The lessons from 1984 are relevant even today, as instances of communal violence and political complicity continue to occur in India.

# Suozzi Leads Letters Demanding Transparency on Private Taxpayer Information Accessed by DOGE

WASHINGTON, D.C. (TIP): Rep. Tom Suozzi (D-NY), on Thursday, February 20, led two letters to the Treasury Inspector General for Tax Administration (TIGTA) and the Government Accountability Office (GAO). These letters request investigations into whether DOGE's access to payment systems has compromised sensitive and confidential taxpayer information.

The letters also express concern that members of the DOGE team were granted access to the Treasury Department's payment systems on January 31st, 2025, in a "read/write"

capacity and "may have occasionally included screenshots of payment systems data or records" in correspondence with other DOGE employees.


Suozzi's letter mimics the exact same language used by Republican Ways and Means Chairman Jason Smith when he wrote a similar letter on February 16th, 2023, raising the same concerns about unauthorized use of private taxpayer data.

Fourteen Ways and Means members joined Suozzi's letter as co-signers.

"A lack of transparency has resulted in widespread confusion regarding the safety of taxpayers' sensitive private

data," the members collectively wrote. "The American people still have no idea of the extent of DOGE's access to and use of confidential taxpayer information. This must be addressed to ensure it complies with 26 U.S.C. § 6103."

"The American people deserve full transparency when it comes to the security of their private information," Suozzi also said. "The fact that DOGE employees may have had unauthorized access to sensitive taxpayer data is deeply troubling. We need answers on what data was accessed, how it was used, and whether taxpayer confidentiality was compromised."

# ASHLEY JUDD, LAWMAKERS, SURVIVORS AND ADVOCATES DEMAND END TO COMMERCIAL SEX TRADE AND JUSTICE FOR SURVIVORS

New Yorkers for the Equality Model Call for Passage of Sex Trade Survivors Justice & Equality Act at NYS Capitol

FEBRUARY 25, 2025

**ALBANY, NY (TIP):** Celebrity activist and survivor Ashley Judd stood with lawmakers and dozens of advocates and survivors of sex trafficking from New Yorkers for the Equality Model (NYFEM), a survivor-led alliance seeking to shrink the exploitative sex trade industry, at the New York State Capitol today calling for the passage of the Sex Trade Survivors Justice and Equality Act (STSJEA) S2005/A1465. Aimed at dismantling the mechanisms of the sex trade, the STSJEA bolsters protections and essential support services for survivors while holding the people who exploit them accountable.

"This legislation will advance the humane, ethical, and just imperative of better protecting women, girls and LGBTQ individuals in the sex trade by increasing services and holding the sex buyers and pimps who are exploiting their economic, social, and other vulnerabilities accountable," said Ashley Judd, actor and global humanitarian. "The harms will continue to impact the most marginalized in our society until we finally hold sex buyers accountable. The demand for our bodies will continue to be met by coercion, violence, force, and exploitation until the Equality Model becomes both law and norm. As a survivor of commercial and private sexual assault, I know well that recovery is a long road, and I'm grateful that this bill accounts for these traumas and the survivors' lived realities."

Sponsored by New York State Senator Liz Krueger (SD-28) and Assemblymember Pamela Hunter (AD-128), the internationally recognized "Equality Model" has seen successful adoption in countries such as Sweden, Norway, France, Canada, Ireland, and Israel. The STSJEA would end the arrests and incarceration of individuals in prostitution, while maintaining strict penalties for buyers and third parties like traffickers and brothel owners.

"I believe the role of government is to champion those with less power against the systems of exploitation that seek to take advantage of their marginalization, and that is why I am proud to sponsor the Sex Trade Survivors Justice & Equality Act," said Senator Krueger. "This is smart, data-driven, progressive legislation crafted with the invaluable input of advocates and sex trade survivors. This bill will empower and support people currently or formerly in the sex trade, while holding pimps, brothel owners, and sex buyers accountable for the harms that they cause."

"While some might believe that sex trafficking is predominantly a New York City issue or a national border issue, the intersection of interstate highways 90 and 81 in my district are also thruways for trafficking victims," said Assemblymember Hunter. "This issue is pervasive throughout the state and for far too long, efforts have been focused on punishing the people who are bought and sold in this multi-billion-dollar industry when they should be on targeting the traffickers, pimps, and sex buyers that perpetuate and uphold this destructive market. My bill, the Sex Trade Survivors Justice & Equality Act, protects the most vulnerable and marginalized individuals who are frequent targets in the sex trade such as members of Black

& Brown communities, the LGBTQ+ population, run away and foster youth, individuals experiencing homelessness, and undocumented immigrants."

The bill seeks to significantly reduce the demand for prostitution which fuels the commercial sex industry, thereby interrupting the cycle of gender-based violence. Furthermore, the STSJEA is designed to enhance New York State's legal measures around sex trafficking, including eliminating loopholes that have previously allowed traffickers, such as Jeffrey Epstein, who trafficked people for themselves, to evade prosecution.

Co-sponsors for the STSJEA include Cordell Cleare (SD-30), Nathalia Fernandez (SD-34), John Liu (SD-16) and Zellnor Myrie (SD-20) in the Senate with Amy Paulin (AD-88), Andrew Hevesi (AD-28), Rodneyse Bichotte-Hermelyn (AD-42), Chris Burdick (AD-93), Maritza Davila (AD-53), Alicia Hyndman (AD-29) and Crystal Peoples-Stokes (AD-141) in the Assembly.

"Upon my first election to the Senate, I pledged to end the scourge of Human Trafficking. I have passed several bills in the interim that are now law," said Senator Cleare. "The Sex Trade Survivors Justice and Equality Act is a necessary step to protect survivors and hold traffickers accountable. I stand with survivors and advocates in demanding justice now!"

"The commercial sex trade is a form of modern-day slavery, and we must break this abusive cycle that continually blames the victims," said Senator Liu. "The Sex Trade Survivors Justice and Equality Act is the right way forward that shifts the focus from punishing survivors to holding traffickers, pimps, and buyers accountable. It's a crucial step toward delivering justice to those who have been trapped in a cycle of manipulation and exploitation."

"As a longtime advocate for survivors, I know that true justice means shifting the burden away from those who are exploited and toward those who exploit," said Assemblymember Paulin. The STSJEA will provide essential protections and services to those who need them most."

"The time to act is now, said Assemblymember Burdick. "By passing the STSJEA, we can send a clear message that New York values the dignity of survivors and will not tolerate the continued exploitation of vulnerable individuals."

The STSJEA also commits to providing comprehensive support services for those wishing to leave the life of prostitution, including undocumented immigrants. These trauma-informed services include housing, legal and immigration assistance, health and mental health services, employment placement, education and training.

"I was coerced into prostitution as a preteen, a time when I should have been protected, not exploited," said Melanie Thompson, Outreach and Advocacy Coordinator for the Coalition Against Trafficking in Women. "Studies have shown that up to 90% of people in prostitution are pimp controlled. The Sex Trade Survivor Justice and Equality Act recognizes the plight of survivors like me and gives us a voice and a path to justice and recovery."

"Survivors like me live with the trauma of exploitation every day, while pimps and sex buyers, the true perpetrators, often escape accountability," said Cristian Eduardo, Co-founder of United Immigrants of New York. "Prostitution is not merely an occupation; it is a form of violence, a pseudo-solution to poverty, and certainly not a path to liberation for the LGBTQIA+ community. The Sex Trade Survivors Justice and Equality Act recognizes this reality by criminalizing those who exploit our vulnerabilities."

"This pivotal legislation cuts the demand that fuels human trafficking, providing comprehensive social services that go beyond immediate legal needs," said Sonia Ossorio, President at National Organization for Women New York City. "It offers medical and legal aid, and immigration assistance, crucial for the recovery and integration of survivors. Crafted from the voices and experiences of survivors, the STSJEA is not just legislation, but a commitment to healing, and a declaration that exploitation has no place in a just society."

"In criminalizing the buyers and pimps who profit from the suffering caused by the sex trafficking industry, this legislation directly targets those responsible for perpetuating its cycle of exploitation," said Alexi Meyers, Director of Anti-Trafficking Policy at Sanctuary for Families. "This is more than just changing laws. It's about restoring dignity and prosperity for those who have been unjustly stripped of it by this abusive and manipulative industry."

# US-based researcher identifies 100 monuments at Lahore Fort dating back to Sikh Empire

To provide a comprehensive understanding of Lahore Fort and its historical significance during the Sikh Empire, the Walled City of Lahore Authority has engaged Dr Tarunjit Singh Butalia to write a tour guidebook

FEBRUARY 27, 2025

**LAHORE/ NEW YORK (TIP):** A US-based researcher has identified some 100 monuments at the Lahore Fort from the era of the Sikh Empire (1799-1849) detailing its historical significance. Of them around 30 monuments do not exist today.

To provide a comprehensive understanding of Lahore Fort and its historical significance during the Sikh Empire, the Walled City of Lahore Authority (WCLA), a government body, has engaged Dr Tarunjit Singh Butalia to write a tour guidebook - Lahore Fort during the Sikh Empire.


"The Lahore Fort, a sentimental monument deeply ingrained in the Sikh psyche, served as the seat of power for the Sikh Empire for nearly half a century.

"It holds a special place in my heart, as my ancestors held esteemed positions within the Sikh court as per Umdat ut Tawarikh - the Persian records of the court," Dr Butalia said in an interview to PTI on Thursday.

"It is very important for Sikhs in India to recognize that 1947 divided Sikh heritage and places of worship into two parts of the world. For a very long time, Sikhs in India were cut off from their historical sites in Pakistan," he said.

Things have changed now with visa liberalization and the presence of a large number of diaspora Sikhs settled in Western countries who are able to visit Pakistan, he said.

The Lahore Fort's rich Mughal history, dating back to the 16th century when Emperor Akbar first constructed it, forms the cornerstone of its importance.

Furthermore, the fort's documented Sikh involvement for half a century adds another layer to its historical narrative.

The expansive Royal Lahore Fort, constructed upon a mud fort by Mughal Emperors Akbar, Jahangir, Shah Jahan and Aurangzeb, was acquired by the Sikh Empire in 1799 and remained under their control until 1849 when the British Empire transformed it into an army garrison.

Maharaja Ranjit Singh, Maharaja Kharak Singh, Kanwar Naunihal Singh and Maharaja Sher Singh preserved many of the fort's structures and constructed several new ones, including the Hazuri Bagh and its magnificent Baradari.

Maharaja Ranjit Singh also

constructed the Gurdwara Dera Sahib, commemorating the site of the martyrdom of Guru Arjan Dev, the fifth Sikh Guru.

"During my first visit in 2019 to Lahore from the US, I experienced a profound connection with the fort. At the Athdhara (pavilion), I could almost sense the footsteps of Sher-e-Punjab Maharaja Ranjit Singh and Ganda Singh Butalia. However, the experience was tinged with sadness, as I was surprised to discover that many of the narratives imparted by tour guides here were predominantly negative when discussing the Sikh era," he said.

Dr Butalia said going through the records, it was revealed that during the Sikh era, the fort was commonly referred

to as Shahi Qila, with occasional instances of being designated as 'Qila Mubarak'.

"During a restful night in Columbus, Ohio, USA, I was captivated by visions of Lahore and its iconic fort. Driven by this inspiration, I embarked on a global quest, delving into libraries, archives, and museums.

"Through my relentless pursuit, I secured over 20 meticulously crafted maps and sketches of the Lahore Fort and its surrounding walled city, dating back to 1825," he said, also crediting the Panjab Digital Library in Chandigarh for his research.

Citing some known books about the history of Lahore Fort, he said "these are the source of much of the misinformation about the Sikh Empire that is disseminated in Pakistan".

He said he has compiled a comprehensive map of Lahore Fort as it stood during the Sikh Empire along with an index of monuments.

This index covers approximately 100 monuments, each identified by its Sikh-era name and detailing its historical significance.

A proposed tour pathway has been devised that commences and concludes at the Bastion Café. "Additionally, historical photographs and sketches have been included for no longer extant monuments, providing a visual representation of the fort's former glory and allowing visitors to experience the long-lost sites as they existed during the Sikh period," Dr Butalia said.

The WCLA will also train its tour guides to use this book. (Source: PTI)

## US grants emergency visa interview to father of critical Indian student

**MUMBAI / NEW YORK (TIP):** The United States has scheduled an emergency visa interview for the father of Nilam Shinde, a 35-year-old Indian student who has been in a coma at a California hospital following a road accident on February 14. The interview will take place at 9 a.m. on Friday.

The development came after the

American division of the Ministry of External Affairs (MEA) reached out to the US government. While emergency travel permits for medical reasons are usually granted swiftly, it remains unclear what caused the delay in this case, NDTV reported, citing sources.

Shinde's family had made a desperate plea to the Centre for assistance after struggling to secure a visa for her father, Tanaji Shinde, who has been trying to travel to the US since learning about the accident on February 16.

A Master of Science student in her final year, Shinde suffered multiple fractures and severe injuries to her chest and head after being hit by a four-wheeler. The hospital treating her sought immediate family consent for brain surgery, according to the family. "We got to know about the accident on February 16 and have been trying for a visa since then. But we haven't got it yet," her father had told NDTV.

## 5 Indian-origin men sentenced to jail, canned over brawl at Singapore hotel

FEBRUARY 26, 2025

**SINGAPORE (TIP):** Five Indian-origin men were sentenced to jail terms between two and three years and caning for being part of a riot that led to the death of a former bouncer at a Singapore hotel.

Sridharan Elangovan was given 36 months in jail and six strokes of the cane; Manojkumar Velayanatham was given 30 months in jail and four strokes; Sashikumar Pakirsamy was given 24 months in jail and two strokes; Puthenvilla Keith Peter was given 26 months' jail and three strokes; and Raja Rishi was given 30 months' jail and four strokes.

Each of them pleaded guilty to a charge of rioting at Singapore's Concorde Hotel and Shopping Mall in 2023, a Channel News report said.

Sridharan, 30, Manojkumar, 32, and Sashikumar, 34, were members of a secret society group.

Another man, Asvain Pachan Pillai Sukumaran, 30, was earlier handed a murder charge after he allegedly killed former bouncer Mohammad Isrrat Mohd Ismail, 29. The Indian-origin man's case is pending.

Six other men, between 25 and 33 years old, were named in court documents as co-accused who took part in the riot.

Isrrat and his friend Muhammad Shahrulnizam Osman, 30, were former bouncers at Club Rumours and members of another secret society.

# A Lighthearted Grievance Regarding Air India Flight AI 144 from Newark to Mumbai on February 12, 2025

"I hope this note finds all Air Indians well, and that they are comfortably seated with ample legroom, unlike my recent experience on Flight AI 144 from Newark to Mumbai on February 12, 2025. Allow me to regale you with the tale of my airborne adventure.

## THE AIRCRAFT: A BLAST FROM THE PAST:

chicken masala accompanied by rice that had all the zest of a damp sponge. The salad was so dry it might have been auditioning for a role in a desert documentary, and the dessert was as inspiring as a Monday morning without coffee.

Dinner's pièce de resistance was a chicken biryani that seemed to have misplaced its invitation to the flavor party. The rice appeared to be plain white grains in disguise, with chicken pieces playing a game of hide and seek. The chickpea salad, adorned with coconut, offered a single bite's worth of adventure before I waved the white flag.

The pre-landing snack was a chicken kati roll, completing the poultry parade. My vegetarian neighbor, meanwhile, was treated to an all-paneer extravaganza, leading me to believe that Air India might be in cahoots with a paneer surplus warehouse.

## BEVERAGE BROUHAHA:

Turning to the beverage service, I was introduced to a whisky brand that was as unfamiliar to me as a snowstorm in Mumbai. The absence of a single malt option left my spirits as low as the economy cabin's legroom. The red wine, a Concha y Toro Merlot, is available in

liquor stores for the price of a fancy cup of coffee. When the cabin crew attempted to serve this vintage in a paper cup, I felt as though I were at a college frat party rather than on a transcontinental flight. Only after a polite protest was, I granted the luxury of a glass.

## ASPIRATIONS AND REALITIES:

If Air India aims to soar alongside the eagles of the airline industry, such as Qatar Airways and Emirates, there is a considerable journey ahead. This experience was a far cry from the golden days when flying with your airline was synonymous with exceptional service.

While I understand that the airline has weathered turbulent times under previous management, I had high hopes that the Tata acquisition would herald a renaissance. Alas, this voyage was more "Nightmare at 20,000 Feet" than "Around the World in 80 Days."

I trust that Air India will take this feedback in the spirit intended and consider the necessary enhancements to restore Air India's reputation to its former glory.

# Sajjan jailed, but 1984's wounds remain open

Media reports continue to refer to it as the 1984 anti-Sikh riots, ignoring the reality that the state machinery had wantonly turned vigilante in seeking vengeance against an entire community for Indira Gandhi's murder.

"But, unfortunately, Kumar is the only prominent Congress politician to be thus sentenced despite the culpability of numerous others in organizing Hindu mobs to hunt down droves of Sikhs, including women and children, on streets, in their homes and workplaces during these 72 hours and slaughtering them. Many victims were brutally 'necklaced' by pinioning their chests and arms with car tires soaked in petrol and setting them alight."

It has taken 40 years to convict former Congress MP Sajjan Kumar for his murderous role in the anti-Sikh pogrom, that raged unchecked across New Delhi after Prime Minister Indira Gandhi was shot dead by her two Sikh bodyguards on October 31, 1984, ending only with her cremation three days later.

But, unfortunately, Kumar is the only prominent Congress politician to be thus sentenced despite the culpability of numerous others in organizing Hindu mobs to hunt down droves of Sikhs, including women and children, on streets, in their homes and workplaces during these 72 hours and slaughtering them. Many victims were brutally 'necklaced' by pinioning their chests and arms with car tires soaked in petrol and setting them alight.

By the time some semblance of order was enforced in the city by the Army, the organized massacres by the State-turned-avenger for the first time in independent India's history, had left some 2,733 Sikhs dead in Delhi alone. Human rights organizations, however, put this number in the capital close to 4,000.

Over decades thereafter, around 15 inquiry commissions, committees and special investigation teams (SITs) determined variously beyond reasonable doubt that these killings were engineered by Congress party loyalists like Kumar and his fellow MPs Kamal Nath, Dharam Dass Shastri, Jagdish Tytler and HKL Bhagat, who died in 2005 without even being tried.

These multiple probes also determined that the extended slaughter was executed by a cross-section of largely Congress party members, sympathizers and bands of hired criminals, all of who carried voter lists to identify Sikh households across Delhi's neighborhoods. Armed

with crude swords, cleavers, scythes, kitchen knives and even scissors and an 'inflammable white powder', these mobs executed their retribution relentlessly, assured immunity from arrest.

Justice SN Dhingra, who was appointed in 2018 to head the SIT to relook at the 186 cases related to the 1984 pogrom, stated in 2022 that the entire endeavor of the Congress government was to ensure that none of the major perpetrators of violence was punished.

Consequently, it appointed Justice Ranganath Misra to head the commission inquiring into the unrest, fully aware that he was in line to become the 21st Supreme Court Chief Justice - which he did in 1990 - and, therefore, would be 'cautious' in his findings. Expectedly, Justice Misra indicted 19 Congress workers, who, ironically, were charged by the People's Union for Civil Liberties with having abetted the massacres, but blatantly absolved the Congress party of all blame.

Subsequently, the Nanavati Commission - the 10th such inquiry committee in 16 years - instituted in 2000 and headed by GT Nanavati, a retired SC judge, recommended prosecutions in 2005 only against Kumar and Tytler. This was despite several witnesses, including this writer, accusing several other Congress MPs and party cadres of their involvement in the violence. Criminal proceedings against Nath are underway, albeit proceeding at a glacial pace.


The Nanavati Commission also revealed that of the original 587 FIRs registered after the 1984 violence, only 25 had resulted in convictions, of which just 12 were for murder. And, of the 440 overall convictions, many cases featured the same person being found guilty of as many as seven counts each. Subsequently, the SC-monitored SIT was formulated in 2018 and continues to ramble on.

Meanwhile, Indira Gandhi's son and successor Rajiv Gandhi justified the pogrom, declaring at a public rally in Delhi's Boat Club on November 19, 1984 that 'Jab bhi koi bada ped girta hai, to dharti thodi hilti hai' (When a big tree falls, the earth shakes a little).

The new PM had fittingly delivered the Congress party's metaphor for the pogrom, even though officialese and media reports at the time, and even now, continue to refer to it as the 1984 anti-Sikh riots, ignoring the reality that the state machinery, including the local police, had openly and wantonly turned vigilante in seeking vengeance against an entire community for Indira Gandhi's murder.

Once Gandhi's funeral pyre was lit, the State stirred itself into action by empowering the Army to restore order, even though the force had been summoned several days earlier.

But the little-known reality regarding

the Army's deployment in Delhi was more complex and sinister. The force, which four months earlier had seamlessly cordoned off Punjab during Operation Blue Star, was provided vague instructions on its deployment by the Central authorities to control Delhi's unmitigated chaos. All it knew was that it was authorized to act in conjunction with the Delhi Police, which itself was rudderless and, for all practical purposes, leaderless and in many instances, as emerged later, conniving in the killings by bloodthirsty mobs.

Using decades-old maps of Delhi colonies, particularly of the killing fields like Trilokpuri in the trans-Yamuna belt, where many roads and colonies were not even marked, the Army was expected to end the violence, detect, evacuate and safely billet Sikh refugees in camps. Further complicating matters was the delineation of its jurisdiction. It merely had loose sanction to impose a curfew, but not enough force, or more importantly, the authorization to implement it.

To his credit, PM Manmohan Singh attempted, in 2005, to mitigate his party's role in the 1984 violence, declaring emotionally in Parliament that he bowed

his head in shame over the massacres and apologized for them. But his party loyalties prevailed, when he declared that the horrific incidents needed to be viewed from a 'wider perspective' as past events could not be undone. He also failed miserably in ensuring that guilty Congressmen, like Kumar, were duly punished. This has only transpired two decades later.

Compensation to pogrom survivors, too, fell prey to officialdom, which required the production of certificates and proof from an uncooperative, almost-hostile administration, loath to either register cases of murder, arson or looting or even to issue death certificates. It seemed that being a Sikh was reason enough to not comply and, consequently, hundreds of illiterate widows, who comprised the bulk of compensation seekers, simply added penury to their overwhelming losses. And, despite the grandiosely announced compensation schemes, hundreds of pogrom survivors were handed cheques for Rs 1,000 and dismissed.

# Note to Europe: Stay Calm and Don't Retaliate

DONALD TRUMP'S TARIFFS RAMPAGE WILL ONLY HURT AMERICANS

It is hard to keep track of all the tariffs that U.S. President Donald Trump is announcing or enacting these days. On top of the 10 percent tariffs that he imposed on China on Feb. 4, Washington has announced across-the-board steel and aluminum tariffs effective March 12 and plans to discuss reciprocal tariffs on all countries on April 2. On the same day, a 25 percent tariff on Canada and Mexico could come into effect, in addition to a tariff specifically targeting U.S. car imports. Yesterday, to round things off, Trump said that he will "very soon" announce a 25 percent tariff on imports from the European Union.

Trump's fixation on tariffs is odd, since such duties make up just about 2 percent of U.S. federal revenues, in line with the average in other high-income economies. Average tariffs also move in a similar range, with the U.S. trade-weighted rate of 2.2 percent not much different from Japan's 1.9 percent and the EU's 2.7 percent.

Seen from Europe, Trump's obsession with tariffs looks alarming. On paper, four of the five proposed measures—the blanket tariff on imports from the EU, the steel and aluminum tariffs, the reciprocal ones, the measures targeting cars—could hit the bloc hard. In turn, over the past weeks, EU officials have been at pains to outline that that tariffs are "bad for business, worse for consumers" and "harmful to the global trading system."

From that perspective, it may seem a little strange that the mainstream assumption appears to be that the EU should retaliate with the same poison and raise tariffs on the United States. This stance makes little sense. Europe has little to gain and possibly a lot to lose from responding to Trump's tariffs.

Economists like to disagree, but they typically see eye to eye on at least one thing: In developed economies, tariffs—a tax that domestic firms and consumers pay on imports—are more often than not a poor idea.

Trump's tariffs do not tick any of these boxes: They are across-the-board, random measures that appear to come and go depending on the presidential mood. In turn, it may not come as a surprise that the tariffs that Trump imposed in 2018 resulted in an estimated net welfare loss of \$7.2 billion in the United States, even after accounting for increased tariff revenues and the gains to some domestic producers benefiting from protection.

This data illustrates an inconvenient truth for tariff fans: Even if some industries benefit a little from the new tariffs (for instance, U.S. steel producers), a wide array of downstream manufacturers face higher costs because of them, which weighs on employment, investment, and exports. In such a scenario, the only option for Washington to mitigate the inflationary impact of



tariffs would be to subsidize costlier U.S. production.

This is not going to happen. Even at high rates, Trump's tariffs will not generate enough money for the U.S. government to splurge-let alone replace income taxes, like Trump fantasized during his election campaign last year.

The issues with tariffs do not end there. Firms typically pass on higher costs to consumers, who eventually shoulder most of the tariff burden. The figures are far from a rounding error: The Peterson Institute for International Economics calculated that if enacted, the proposed tariffs on Mexico and Canada (on top of the 10 percent tariff already imposed on China) could cost a typical U.S. household at least \$1,200 per year.

Retaliatory tariffs on the United States would be just as bad an idea for Europe. If the EU goes down that road, European manufacturers would face higher input costs at a time when many sectors already struggle amid high energy prices and growing Chinese competition. (German carmakers come to mind as a particularly good example of firms that would be most affected.)

And just like U.S. tariffs will hurt American households, EU tariffs would also act as a tax on European consumers, fueling inflation at a time when the cost of living is already their top concern, according to a survey conducted by the European Parliament last year. By contrast, estimates suggest that avoiding retaliation to U.S. tariffs would result in minimal hit to EU GDP, a reduction of just 0.1 percent. (This modeling assumes a U.S. tariff rate of 60 percent on China and a rate of 10 percent on other economies).

Beyond economics, it is not hard to see how Europeans could end up in bitter political fights over the shape of retaliatory tariffs. Many EU economies have deep trade ties to the United States in one way or another. Some of them (such as Austria, Finland, Germany, Ireland, Italy, and Portugal) ship more than 20 percent of their extra-EU exports to the United States, suggesting that their willingness to risk triggering an unpredictable transatlantic trade war could be low.

And many EU economies (including

Belgium, France, Ireland, Lithuania, Luxembourg, and the Netherlands) rely on the United States as a top source of imports, meaning that EU tariffs would fuel domestic inflation. Add the fact that yet other member states, such as Sweden, want any prospective retaliation to conform to World Trade Organization rules, which is virtually impossible. Arriving at an EU-wide consensus on how to respond to Trump will clearly be hard.

The issues with EU coordination would not end there, for at least two reasons. First, Trump's insistence on treating EU countries on a case-by-case basis means that EU governments face a prisoner's dilemma. Game theory suggests that going it alone and trying to cut bilateral deals with Trump, instead of collaborating with EU neighbors, could leave them better off. Some member states, such as Hungary, appear keen to cozy up to Trump anyway, making it unlikely that they would be on board with anything more than a symbolic EU tariff. Second, the risk of fragmentation is also high when it comes to the European Commission's package of carrots that are supposed to convince Trump to spare the EU from tariffs; proposals include pledges to buy more U.S. weapons (a nonstarter for France) and get tougher on China (good luck with that in Germany).

This begs the question of how, if not with tariffs, Europeans should respond to Trump's actions. Looking in the mirror and addressing the EU's own trade weaknesses would be a good start. Intra-EU trade costs and barriers are so high that on average, they are equivalent to a tariff of 44 percent on shipments of goods (excluding agriculture) and 110 percent for services exchanges across EU member states—far more than any tariff Trump will ever impose on the bloc.

Such barriers include poor border infrastructure, the lack of regulatory harmonization, and the coexistence of many national procurement regimes. Europe's willingness to impose de facto tariffs on itself comes with serious consequences: Trade across EU member states is less than half the level of trade among U.S. states.

And in the area of trade, completing the European Union's "Single Market" is

not the only item that should be at the top of the bloc's to-do list. Inking trade agreements with developing economies, starting with the Mercosur bloc, also comes to mind at a time when EU firms worry that tariffs will weigh on their exports to the United States.

If doing nothing in retaliation is not an option for political reasons, then EU leaders could do worse than looking at China for tips on smart retaliation. Following the imposition of Trump's 10 percent tariff on all U.S. imports of Chinese goods, Beijing's response has been remarkably muted. China enacted a 15 percent tariff on imports of U.S. liquefied natural gas and coking coal, in addition to a 10 percent tariff on crude oil. Altogether, these cover only \$13.9 billion of annual imports from the United States, or just 0.5 percent of China's total imports.

In doing so, Beijing has adopted a sensible strategy of imposing surgical retaliatory tariffs that will support its long-stated goal of boosting energy security. This is exactly what Europeans should do: use Trump 2.0 as an opportunity to turbocharge the adoption of policies that they need to implement anyway in order to boost their economic prospects.

All things considered, Europeans may be better off being the adults in the room and letting Trump hurt the U.S. economy if he so wishes. Retaliatory tariffs enacted by the EU would not only fail to solve the issue (no, Trump will not back down), but they would also create a slew of new problems for Europeans.

By contrast, avoiding retaliation means that the economic costs of tariffs would be borne mostly by American businesses and households. At a time when all the talk in Europe is about narrowing the growing gap between the EU and U.S. economies, this would not be an entirely bad thing.

# GREAT POWERS DON'T BLUFF

Instead of speaking softly and carrying a big stick, as former President Theodore Roosevelt once advocated, President Donald Trump has threatened to turn Canada into the 51st state, to annex Greenland from Denmark, and to forcibly displace 2 million Palestinians to create the Gaza Riviera.

By doing so, Trump is continuously breaking one of the cardinal rules of international relations—great powers don't bluff. Though bluffing might work in poker or business, it has profound but often unintended consequences in international relations.

Like former Presidents George W. Bush, Barack Obama, and Joe Biden before him, Trump is attempting to reset America's relationship with Russia—again. Not only does this take his bluffing to new heights, but he is also sacrificing his political capital, and driving a wedge between Washington and its allies—namely, but not exclusively,

under the pretext of pulling Moscow away from Beijing.

Moral reprehensibility aside, Trump's rehabilitation of Russian war criminal Vladimir Putin is destined to fail for at least two reasons. First, though China and Russia are not allies in the western sense of the word, they have spent more than a decade collaborating to undermine America's credibility and reduce its primacy in the international system—steering them in a separate direction is almost impossible.

Second, Vladimir Putin cannot be bought or replaced. He fears Russian society revolting against his rule, but also being murdered in a palace coup orchestrated by the Siloviki, being prosecuted by his successors, or being hunted by his enemies if he were ever granted exile. Like Adolf Hitler and Joseph Stalin before him, a dictator of his stature has no choice but to remain in power, and therefore to continue his crusade against Ukraine and the West, until he dies, is defeated, or deposed.

Rather than pulling Moscow away from Beijing, as former President Richard Nixon and former Secretary of State Henry Kissinger once divided the Sino-Soviet alliance, the concessions Trump offers to the Russian dictator will likely be pocketed. To say that Trump is overplaying America's hand with regard to Russia is an understatement. Worst of all, this sends the wrong signals to all relevant actors and interested observers. To America's allies, it serves as a warning to reduce dependence on Washington and look for partners elsewhere. To America's adversaries, it reveals that it's bad to be Washington's enemy, but far worse to be its ally.

Europe holds the strongest hand against Russia—not Washington. While commerce between Moscow and America has always been insignificant, that was not the case for European trade flows with Russia before the Russian war criminals invaded peaceful Ukraine on February 24, 2022. The overwhelming majority of Russia's estimated \$300 billion in frozen assets are also held in Europe, not in America.

Trump is overplaying his hand against Ukraine too. America has some 100,000 troops deployed across Europe. In the event of a land war against Russia, NATO might be able to deploy another

half a million at best. Meanwhile, Ukraine's Armed Forces stand at 1 million soldiers strong, and they serve no other purpose than to defend European civilization against Russian barbarism.

Instead of supporting Ukraine's resolution commemorating the third anniversary of Russia's invasion at the United Nations—or committing to permanently deploy a contingent of American troops at "Fort Trump" in Poland, to be built and paid for by the Polish government—Trump is simply teaching Europe to learn to live without America.

Old habits die hard, and Trump's negative perception of NATO is decades old. His commitment to America's European allies is shaky at best, and nobody in their right minds still believes that Trump would endanger New York or Washington to attack—let alone to nuke—Moscow or Saint Petersburg in defense of Warsaw or Paris. That will never happen, so Europe must make adjustments.

Power abhors a vacuum. As America reduces its commitment to the old continent, Europe will simply forge closer ties with Ukraine and Turkey, the two most powerful armies in the region, for protection against Moscow. Britain and France allied with the Ottoman Empire against Russia (and Greece) during the Crimean War, and Europe will seek a similar arrangement in the next era of European geopolitics. Such is the nature of the balance of power.

From the Punic Wars to the Napoleonic Wars to the Cold War, the rules of geopolitics have been consistent for thousands of years. Great power competition doesn't change just because the head of state is sympathetic to the other party, as Trump is toward the war criminal Putin. I fear that both Trump and America are going to learn that lesson the hard way. Sooner rather than later, in the Indo-Pacific.

# Dirty Dozen tax scams for 2025: IRS warns taxpayers to watch out for dangerous threats

FEBRUARY 27, 2025

**WASHINGTON D.C. (TIP):** The Internal Revenue Service today announced its annual Dirty Dozen list of tax scams for 2025 with a warning for taxpayers, businesses and tax professionals to watch out for common schemes that threaten their tax and financial information.

Ranging from email schemes to misleading tax credits, many of the Dirty Dozen items peak during filing season as people prepare their tax returns. In reality, these scams can occur throughout the year as fraudsters look for ways to steal money, personal information and data.

The IRS' annual Dirty Dozen campaign lists 12 scams and schemes that threaten taxpayers. While the Dirty Dozen is not a legal document or a formal listing of agency enforcement priorities, the education effort is designed to raise awareness and protect taxpayers and tax pros from common tax scams and schemes.

"Scammers are relentless, and they use the guise of tax season to try tricking taxpayers into falling into a variety of traps. These red flags can lead to everything from identity theft to being misled into claiming tax credits for which they're not entitled," said Terry Lemons, IRS communications senior adviser. "For more than two decades, the IRS has highlighted the Dirty Dozen through far-reaching communications and education campaigns as part of a wider effort by the agency to protect taxpayers from being scammed."

Under Lemons' leadership, the IRS created the Dirty Dozen campaign in 2002 to counter emerging scams being seen across the country. Combined with related efforts by the Security Summit, the IRS has worked for a decade with state tax agencies and the nation's tax software and financial industry as well as tax professionals to educate taxpayers about scams and fraudulent schemes.

The Dirty Dozen list often has cautioned taxpayers about tax-related identity theft, in support of the Security Summit's ongoing efforts in this area, that have led to protecting millions of taxpayers and billions of dollars from refund fraud.

Last year, the tax community launched a related effort called the Coalition Against Scam and Scheme Threats (CASST) following a surge in social media-fueled scams.

As part of these continuing efforts to protect taxpayers against constantly evolving scams, the 2025 IRS Dirty Dozen list highlights the following 12 pervasive threats:

**EMAIL PHISHING SCAMS:** The IRS continues to see a barrage of email and text scams targeting taxpayers and others. Taxpayers and tax professionals should be alert to fake communications from entities posing as legitimate organizations in the tax and financial community, including the IRS, state tax agencies and tax software companies. These messages arrive in the form of unsolicited texts or emails to lure unsuspecting victims into providing valuable personal and financial information that can lead to identity theft. There are two main types:

**PHISHING:** An email sent by fraudsters claiming to come from the IRS. The email lures the victims into the scam with a variety of ruses such as enticing victims with a phony tax refund or threatening them with false legal or criminal charges for tax fraud.

**SMISHING:** A text or smartphone SMS message where scammers often use alarming language such as, "Your account has now been put on hold," or "Unusual Activity Report," with a bogus "Solutions" link to restore the recipient's account. The promise of unexpected tax refunds is another potential tactic used by scam artists.

As a reminder, never click on any unsolicited communication claiming to be from the IRS as it may surreptitiously load malware. This may also be a way for malicious hackers to load ransomware that keeps the legitimate user from accessing their system and files.

The IRS has special information available to help people understand and report email scams.

**BAD SOCIAL MEDIA ADVICE:** Another growing

concern in 2025 continues to involve incorrect tax information on social media that can mislead honest taxpayers with bad advice, potentially leading to identity theft and tax problems. Social media platforms routinely



circulate inaccurate or misleading tax information, including on TikTok where people share wildly inaccurate tax advice. Some involve urging people to misuse common tax documents like Form W-2.

The IRS and CASST warn people not to fall for these scams, and urge them to follow trusted social media advice from the IRS, tax professionals and other reputable sources. The IRS reminds taxpayers who knowingly file fraudulent tax returns that they could potentially face significant civil and criminal penalties.

**IRS INDIVIDUAL ONLINE ACCOUNT HELP FROM SCAMMERS:** Swindlers can pose as a "helpful" third party and offer to help create a taxpayer's IRS Individual Online Account at IRS.gov. In reality, no help is needed, and the agency offers tips on how to sign up and avoid scams. The IRS Individual Online Account provides taxpayers with valuable personal tax information. But watch out: Third parties making these offers will try to steal a taxpayer's personal information and try to submit fraudulent tax returns in the victim's name to get a big refund.

**FAKE CHARITIES:** Bogus charities are a perennial problem that can intensify whenever a crisis or natural disaster strikes. Scammers set up these fake organizations to take advantage of the public's generosity. They seek money and personal information, which can be used to further exploit victims through identity theft.

Taxpayers who give money or goods to a charity might be able to claim a deduction on their federal tax return if they itemize deductions, but charitable donations only count if they go to a qualified tax-exempt organization recognized by the IRS.

**FALSE FUEL TAX CREDIT CLAIMS:** A major concern during the past year involved taxpayers who were misled into believing they were eligible for the Fuel Tax Credit. The credit is meant for off-highway business and farming use and is not available to most taxpayers. However, unscrupulous tax return preparers and promoters, including people on social media, continue enticing taxpayers into inflating their refunds by erroneously claiming the credit. The IRS has seen an increase in the promotion of filing certain refundable credits using Form 4136, Credit for Federal Tax Paid on Fuels. The IRS urges people to get more information and ensure they are properly claiming this credit.

**CREDITS FOR SICK LEAVE AND FAMILY LEAVE:** This specialized credit is available for self-employed individuals for 2020 and 2021 during the pandemic; the credit is not available for later tax years. The IRS is seeing repeated instances where taxpayers are using Form 7202, Credits for Sick Leave and Family Leave for Certain Self-Employed Individuals, to incorrectly claim a credit based on income earned as an employee and not as a self-employed individual.

**BOGUS SELF-EMPLOYMENT TAX CREDIT:** Social media advice continues to circulate about a non-existent "Self-Employment Tax Credit" that's misleading taxpayers into filing false claims. Promoters market it as a way for self-employed people and gig workers to get big payments for the COVID-19 pandemic period. Similar to misleading marketing around the Employee Retention Credit, there is inaccurate information being circulated that suggests many people qualify for the tax credit and payments of up to \$32,000 when they actually do not.

In reality, the underlying credit being referred to in social media is not called the "Self-Employment Tax Credit," it's a much more limited and technical credit called the Credits for Sick Leave and Family Leave. Many people simply do not qualify for these credits, and the IRS is closely reviewing claims coming in under this provision, so taxpayers filing claims do so at their own risk.

**IMPROPER HOUSEHOLD EMPLOYMENT TAXES:** Taxpayers "invent" fictional household employees and then file Schedule H (Form 1040), Household Employment Taxes, to claim a refund based on false sick and family medical leave wages they never paid.

**THE OVERSTATED WITHHOLDING SCAM:** This is a recent scheme circulating on social media encouraging people to fill out Form W-2, Wage and Tax Statement, or other forms like Form 1099-NEC and other 1099s with false income and withholding information.

In this overstated withholding scheme, scam artists suggest people make up large income and withholding amounts as well as the fictional employer supplying those amounts. Scam artists then instruct people to file the bogus tax return electronically in hopes of getting a substantial refund due to the large amount of fraudulent withholding.

If the IRS cannot verify the wages, income or withholding credits entered on the tax return, the tax refund will be held pending further review. Taxpayers should always file a complete and accurate tax return. They should only use legitimate information returns, such as an employer issued Form W-2, to complete returns correctly.

There are multiple variations of the overstated withholding credit scheme, including those involving Forms W-2 and W-2G; Forms 1099-R, 1099-NEC, 1099-DIV, 1099-OID and 1099-B; as well as the Alaskan Dividend Fund, Schedule K-1 with Withholding Reported, and Unspecified Source of Withholding Credit Claimed.

**MISLEADING OFFERS IN COMPROMISE:** The Offers in Compromise (OIC) program is an important program that helps people settle their federal tax debts when they are unable to pay in full. But "mills" can aggressively promote Offers in Compromise in misleading ways to people who clearly don't meet the qualifications, frequently costing taxpayers thousands of dollars. A taxpayer can check their eligibility for free using the IRS Offer in Compromise Pre-Qualifier tool.

**GHOST TAX RETURN PREPARERS:** Most tax preparers provide outstanding and professional service. However, people should be careful of shady tax professionals and watch for common warning signs, including charging a fee based on the size of the refund. A major red flag or bad sign is when the tax preparer is unwilling to sign the return. Avoid these "ghost" preparers, who will prepare a tax return but refuse to sign or include their IRS Preparer Tax Identification Number (PTIN) as required by law. Taxpayers should never sign a blank or incomplete return. Instead, the IRS reminds taxpayers to turn to a trusted tax professional for help.

**NEW CLIENT SCAMS AND SPEAR PHISHING:** In 2025, the IRS continues to see the "new client" scam, which involves spear phishing attempts that target tax pros. Cybercriminals impersonate new, potential clients to trick tax professionals and other businesses into responding to their emails. Once the tax pro responds, the scammer sends a malicious attachment or URL that can compromise the preparer's computer systems and allow the attacker to access sensitive client information.

Phishing is a term given to emails or text messages designed to get users to provide personal information, and spear phishing is a phishing attempt tailored to a specific organization or business.

# Snap winter election a challenge, but Elections Ontario says it is ready for a freezing voting day

TORONTO (TIP):

When Shafoli Kapur, an immigration consultant, moved to Canada in 2009, she couldn't have imagined that she would be running for a seat in the Ontario Provincial Assembly in 2025. Her journey to becoming a dedicated community leader and advocate is rooted in her strong educational foundation and relentless drive to make a positive impact on the lives of others.

It is after 143 years that provincial elections are being held in February. Incumbent Conservative Premier Doug Ford called the election on January 28, launching a 31-day campaign with voting on February 27. It is also more than a year early. Ford already had a commanding majority and had time until June 2026 to hold the polls.

The short campaign and the wintery weather have thrown wrenches into election planning. Still, Dave Allston, returning officer for Ottawa Centre and a veteran Elections Ontario employee, says the province is ready for election day. Ontario in general and GTA in particular witnessed unprecedented snowstorms last week. The weather has tossed another curveball thanks to the snowiest February in Ottawa in nearly a decade. The snow has made it difficult to put up election signs, so candidates have chosen to zip-tie signs to fences and poles. City bylaw officers and Elections Ontario workers must use wire cutters to remove signs that have been placed illegally, particularly those that were too close to advance polling stations. "We were going out today buying salt. My biggest worry was snow on election day, but now it's looking like two or three days of thaw followed by a flash freeze," says Dave Allston.

"Then there are the stations themselves. We will have 2,000 people walking through with slush on their boots that create a slipping hazard. We're hiring extra people to clean."

Snowbanks and narrow streets might also cause parking woes around some polling stations, "but that's not something Elections Ontario can control," he said. Fortunately, in urban ridings like Ottawa Centre, no one should be more than five or six blocks from their polling station.

The weather has failed to dampen the spirit of the contestants. Despite a fall in several contestants and the ongoing tariff war with the neighboring US - Donald Trump has once again deferred the new tariffs until the first week of April - the battle of the ballot involving four major political parties, including the ruling Conservatives, New Democrats, Liberals and Greens, there are new entrants to the political scenario, including New Blue Party.

Nearly three dozen candidates of Indian descent are in the fray. If Shafoli Kapur is representing Liberals, who are trying to wrest back a major share in the political domain of the biggest province of Canada, young Indo-Canadians are representing all major political parties. A few of them are contesting as Independents as well.

After completing her degree in Electrical Engineering, Shafoli Kapur embraced the entrepreneurial spirit and, over the past 12 years, has built a thriving business from the ground up.

## Man accused of raping woman inside bus at Pune depot arrested after 2-day manhunt

The man accused of raping a 26-year-old woman inside a bus at Pune's Swargate depot has been arrested in Maharashtra's Shirur during a midnight operation following a massive manhunt, police said on Friday, February 28.

The accused, Dattatray Ramdas Gade (37), was hiding at a farm in Shirur. Since Feb 27, 13 teams of Pune Police had been searching for him. Late at night, he visited someone's house for a meal, and that person immediately alerted the police, leading to his arrest, officials said.

Gade allegedly raped the woman while she was waiting for a bus to Satara district at one of the platforms around 5.45 am on Tuesday. He misled her by saying that the bus for Satara had arrived at another platform.

He then took her to an empty 'Shiv Shahi' AC bus parked elsewhere on the premises. As the lights inside the bus were off, she hesitated to get in, but he convinced her that it was the right vehicle. Once inside, Gade followed her and raped her, the woman, who works in the medical field, told the police.

The incident triggered a widespread outrage, with people across society, including political leaders, demanding strict action and justice.

Gade, a resident of Gunat village in Pune, has been named in half a dozen cases of theft, robbery, and chain-snatching in Pune and Ahilyanagar districts. He had been out on bail since 2019 in one of the cases.

As Gade remained at large for over two days, a reward of Rs1 lakh was announced for anyone providing information about his whereabouts. A hotline number was also released for tip-offs.

Earlier on Friday, Pune City and Pune Rural Police launched a search operation in Gunat village, including sugarcane fields, using drones and dog squads, officials said. More than 100 police personnel were deployed in the village, they added.

Swargate in Pune is one of the largest bus depots of the Maharashtra State Road Transport Corporation (MSRTC).

# India criticises secrecy in UNSC listing rejections, calls it a 'disguised veto'

NEW FELHI (TIP)

India's UN envoy P Harish, at a debate on working methods, stressed the urgent need for reform in the 15-member UNSC and its functioning on Thursday, February 27.

Underlining the need for more transparency in workings of the UN Security Council's subsidiary bodies, India said details about rejecting or putting on hold requests to blacklist terror entities are not made public and are the exclusive preserve of a select few, calling it a "disguised veto".

India's Permanent Representative at the UN Ambassador P. Harish spoke at the Inter-Governmental Negotiations Plenary - Cluster Debate on Working Methods here Thursday and underscored the need for urgent reform of the 15-nation Security Council and its working methods - from more transparency in the working of the subsidiary bodies to implementation of peacekeeping mandates.

"The demand in this Chamber for reforms is loud and clear. This call gains greater significance at a time when the world is expressing apprehensions at the ability of the United Nations to deliver, to meaningfully intervene on issues of key importance to humanity in different parts of the globe, particularly in the realm of peace and security - which remains the core mandate of the Council," Harish said.

Highlighting specific areas with regard to working methods for the Council that call for urgent reforms, Harish said there

needs to be more transparency in the working of the subsidiary bodies of the Council.

Citing a specific example, he said, "While decisions on listing are made public, details pertaining to rejection or putting on technical hold of listing requests are the exclusive preserve of a select few. This is indeed a disguised veto."

India has repeatedly voiced concern over the manner in which the Council's subsidiary bodies such as the 1267 Al Qaida Sanctions Committee operate while dealing with requests to blacklist terror entities and individuals.

Delhi has drawn the attention of the world body to the fact that genuine, evidence-based listing proposals for globally sanctioned terrorists are blocked without giving any due justification, saying this is uncalled for

and smacks of double speak when it comes to the Council's commitment in tackling the challenge of terrorism. On various occasions in the past, the Council's veto-wielding member China, an all-weather friend of Pakistan, has placed holds and blocks on bids by India to list Pakistan-based terrorists.

India lamented that while an overwhelming number of Member States acknowledge that reforms are indeed an imperative, there has been practically no progress along this direction.

"We have had numerous discussions and debates. We speak passionately but we continue to be where we are," the Indian envoy said.

Calling on the UN membership to act on the long-delayed UNSC reforms, Harish said Member States cannot be losing anymore time in exchanging ideas and engaging in discussions alone.

## Prayagraj saw over 2,000 flights, 100 business jets during Maha Kumbh

NEW DELHI (TIP)

In its original form, Maha Kumbh is considered a gathering of saints, mystics and devotees. This year's congregation was significant in at least one more aspect: it turned out to be a 'kumbh' of aircraft as well. The domestic airport in Prayagraj welcomed a record number of flights during this period.

As per data verified by India Today's Open-Source Intelligence (OSINT) team, the domestic airport in Prayagraj saw more than 2,000 flights during the Maha Kumbh between January 13 and February 26. Before its start, the Prayagraj Airport handled around 15 daily flight movements. Cut to February 18, this number surged to a record 120.

On average, the Prayagraj Airport handled over 100 flights per day, a seven-



fold jump from its pre-Kumbh daily average. Open-source flight tracking data reveals 2,158 flight movements during the Maha Kumbh.

The daily maximum of 49 flights landed at Prayagraj Airport on February 22-23, ahead of Maha Shivratri on February 26 and the festival's

conclusion. A similar trend of spike in flight arrivals was observed before other Shahi Snan days, with 15 flights on Makar Sankranti (January 14), 22 on Mauni Amavasya (January 29), 22 on Basant Panchami (February 3), and 27 on Maghi Purnima (February 12).

Delhi was the biggest source of flights to Prayagraj during the 45-day period, with 383 flights originating from the national capital. It was followed by Mumbai (159), Bengaluru (101), Ahmedabad (92), Hyderabad (78), and Kolkata (76).

Beyond metros, domestic airports such as Agra (2), Varanasi (3), Kochi (1), Guwahati (11), Bhopal (2), Pune (6), Dehradun (4), and Bilaspur (5) also ferried passengers to Prayagraj. Additionally, 18 flights arrived from Jaipur, while nine originated from Indore.

# Central govt opposes life ban on convicted lawmakers

NEW DELHI (TIP)

Asserting that it was a matter “within the legislative policy of Parliament”, the Centre on Wednesday, February 26, opposed before the Supreme Court a PIL seeking to debar convicted lawmakers for life from contesting polls, forming political parties and holding any post in a political party.

“The question whether a lifetime ban would be appropriate or not is a question that is solely within the domain of the Parliament,” the Centre said in an affidavit filed in response to a PIL filed by advocate Ashwini Kumar Upadhyay in 2016, seeking life ban on convicted persons from contesting polls.

Under the current election law, a convicted person is immediately disqualified and he/she is also debarred from contesting election for six years from the date of completion of his sentence. But the disqualification disappears after the expiry of six years from the date of completion of his/her sentence. The affidavit came barely two weeks after the Supreme Court expressed serious concern over criminalisation of politics and asked the Centre and Election Commission to spell out their respective stand on the contentious issue.

A bench of Justice Dipankar Datta and Justice Manmohan had on February 10 wondered how a person convicted of crime can be permitted to come back to the Parliament and state assemblies. “Once he is convicted, and the conviction is upheld...and after that how can such people come back to Parliament and (state) legislatures?... that they (Centre and EC) have to answer. There is also an apparent conflict of interest. They would be making the laws,” the bench had said. “Criminalisation of politics is a serious concern. The Election Commission must have deliberated on this and proposed a better solution than what has been presented before us,” it had



said, posting the matter for further hearing on March 4.

The top court had also sought the assistance of Attorney General R Venkataramani as the PIL also challenged the validity of Sections 8 and 9 of the Representation of People’s Act (RPA) 1951, which disqualified convicted politicians from holding elected positions for a limited period only.

“Today, the law allows a person convicted of murder to serve as the chairman of a nationally recognised political party. This is a serious issue that requires judicial scrutiny,” senior counsel and amicus curiae Vijay Hansaria had pointed out.

On behalf of the petitioner, senior counsel Vikas Singh had said, “What we are seeing is 46 to 48 per cent people with kidnapping, rape, murder charges coming back to the Parliament, where the sentences are for lesser period of time. This could never have been the intention of the Parliament, while drafting this section.”

## Hindi, Sanskrit destroyed 25 North Indian languages: Stalin targets Centre

Upping the ante against alleged Hindi imposition by the Centre, Tamil Nadu Chief Minister M K Stalin on Thursday, Feb 27, once again said the state will not allow the “imposition” of the language and vowed to protect Tamil and its culture.

“Will oppose Hindi imposition. Hindi is the mask, Sanskrit is the hidden face,” he said in a letter to partymen.

The ruling DMK has been alleging Hindi imposition by the Centre through the 3-language formula as part of the National Education Policy (NEP), a charged denied by the Union Government. In the letter, Stalin claimed many North Indian languages spoken in Bihar, Uttar Pradesh and Madhya Pradesh such as Mythili, Brajbhasha, Bundelkhandi and Awadhi “have been destroyed by the hegemonic Hindi.” “More than 25 north Indian native languages have been destroyed by the invasion of hegemonic Hindi-Sanskrit languages. The century-old Dravidian movement safeguarded Tamil and its culture because of the awareness it created and the various agitations,” the ruling DMK chief said. Tamil Nadu is opposing NEP because the Centre is trying to impose Hindi and Sanskrit through the education policy, he added.

LAHORE (TIP)

A US-based researcher has identified some 100 monuments at the Lahore Fort from the era of the Sikh Empire (1799-1849) detailing its historical significance. Of them around 30 monuments do not exist today.

To provide a comprehensive understanding of Lahore Fort and its historical significance during the Sikh Empire, the Walled City of Lahore Authority (WCLA), a government body, has engaged Dr Tarunjit Singh Butalia to write a tour guidebook — Lahore Fort during the Sikh Empire.

“The Lahore Fort, a sentimental monument deeply ingrained in the Sikh psyche, served as the seat of power for the Sikh Empire for nearly half a century.

“It holds a special place in my heart, as my ancestors held esteemed positions within the Sikh court as per Umdat ut Tawarikh – the Persian records of the court,” Dr Butalia said in an interview to PTI on Thursday, February 27.

“It is very important for Sikhs in India to recognise that 1947 divided Sikh heritage and places of worship into two parts of the world. For a very long time, Sikhs in India were cut off from their historical sites in Pakistan,” he said.

Things have changed now with visa liberalisation and the presence of a large number of diaspora Sikhs settled in Western countries who are able to visit Pakistan, he said.

The Lahore Fort's rich Mughal history, dating back to the 16th century when Emperor Akbar first constructed it, forms the cornerstone of its importance. Furthermore, the fort's documented Sikh involvement for half a century adds another layer to its historical narrative.

The expansive Royal Lahore Fort, constructed upon a mud fort by Mughal Emperors Akbar, Jahangir, Shah Jahan and Aurangzeb, was acquired by the Sikh Empire in 1799 and remained under their control

until 1849 when the British Empire transformed it into an army garrison.

Maharaja Ranjit Singh, Maharaja Kharak Singh, Kanwar Naunihal Singh and Maharaja Sher Singh preserved many of the fort's structures and constructed several new ones, including the Hazuri Bagh and its magnificent Baradari.

Maharaja Ranjit Singh also constructed the Gurdwara Dera Sahib, commemorating the site of the martyrdom of Guru Arjan Dev, the fifth Sikh Guru.

“During my first visit in 2019 to Lahore from the US, I experienced a profound connection with the fort. At the Athdhara (pavilion), I could almost sense the footsteps of Sher-e-Punjab Maharaja Ranjit Singh and Ganda Singh Butalia. However, the experience was tinged with sadness, as I was surprised to discover that many of the narratives imparted by tour guides here were predominantly negative when

discussing the Sikh era,” he said.

Dr Butalia said going through the records, it was revealed that during the Sikh era, the fort was commonly referred to as Shahi Qila, with occasional instances of being designated as ‘Qila Mubarak’.

“During a restful night in Columbus, Ohio, USA, I was captivated by visions of Lahore and its iconic fort. Driven by this inspiration, I embarked on a global quest, delving into libraries, archives, and museums.

“Through my relentless pursuit, I secured over 20 meticulously crafted maps and sketches of the Lahore Fort and its surrounding walled city, dating back to 1825,” he said, also crediting the Panjab Digital Library in Chandigarh for his research.

Citing some known books about the history of Lahore Fort, he said “these are the source of much of the misinformation about the Sikh Empire that is disseminated in Pakistan”.

He said he has compiled a comprehensive map of Lahore Fort as it stood during the Sikh Empire along with an index of monuments.

This index covers approximately 100 monuments, each identified by its Sikh-era name and detailing its historical significance.

A proposed tour pathway has been devised that commences and concludes at the Bastion Café. “Additionally, historical photographs and sketches have been included for no longer extant monuments, providing a visual representation of the fort's former glory and allowing visitors to experience the long-lost sites as they existed during the Sikh period,” Dr Butalia said.



The first act closes with the United States premiere of Qasim Naqvi's 'God Docks at Death Harbor' (Piano Quintet Version) as Nimbus Dance joins the stage with choreography titled, 'Dark Water' in Newark and Red Bank.

The program continues with Stravinsky's Divertimento from 'The Fairy's Kiss,' which was drawn from a neoclassical ballet based on 'The Ice Maiden,' a tale by author Hans Christian Andersen. The second half of the program concludes with Stravinsky's Suite from 'The Firebird' with Nimbus Dance appearing on center stage for both performances in Newark. Originally performed in Paris in 1910 by Sergei Diaghilev's Ballets Russes, the piece was then reduced for solo piano and extracted as a concert suite in 1911 and was ultimately re-orchestrated by Stravinsky in 1919.

## XIAN ZHANG

2024-25 marks the GRAMMY and Emmy Award-winning conductor Xian Zhang's ninth season as music director of the New Jersey Symphony. Starting in 2025-26, Zhang will also hold the role of music director at Seattle Symphony. Zhang holds the position of conductor emeritus of Orchestra Sinfonica di Milano, having previously held the position of music director, 2009-2016.

The 2024-25 season sees Zhang return to the Metropolitan Opera in New York to conduct David McVicar's acclaimed production of Puccini's Tosca.

Zhang is in high demand as a guest conductor, appearing regularly with Philadelphia Orchestra and Los Angeles Philharmonic, returning to both in 2024-25. Her recording with Philadelphia Orchestra and Time for Three, 'Letters for The Future' (released 2022 on Deutsche Grammophon), won multiple GRAMMY Awards in the Best Contemporary Classical Composition (Kevin Puts' 'Contact'), and Best Classical Instrumental Solo categories.

Following a successful collaboration at Tanglewood Festival 2023, Zhang returns to the Boston Symphony Orchestra this season.

Zhang previously served as principal guest conductor of the BBC National Orchestra & Chorus of Wales, the first female conductor to hold a titled role with a BBC orchestra and principal guest conductor of Melbourne Symphony Orchestra. In 2002, she won first prize in the Maazel-Vilar Conductor's Competition. She was appointed New York Philharmonic's assistant conductor in 2002, subsequently becoming their associate conductor and the first holder of the Arturo Toscanini Chair. As a performer, Pott danced as a soloist with the Martha Graham Dance Company, performing in iconic roles. Prior to joining the Graham company, Mr. Pott performed as a lead dancer with American Repertory Ballet, Oakland Ballet, and Savage Jazz Dance Company, in a wide range of new and classical repertory.

A recipient of Choreography Fellowships from the New Jersey State Council on the Arts in 2008, 2017, and 2023, and named a Distinguished Teaching Artist by the Council in 2012, Pott was one of 25 arts leaders nationally selected for the Association of Performing Arts Presenters' (APAP) inaugural Leadership Fellows Program, serves on the Dance Advisory Council for New Jersey Performing Arts Center, and is a co-founder of the Jersey City Arts Council.

Nimbus reaches over 16,000 people annually, performing throughout the NJ/NY area and nationally, including recently with the Boston Symphony Orchestra at Tanglewood. The School of Nimbus and outreach programs reach over 4000 youth each year, with scholarships available to ensure that no student is turned away for lack of funds.

Following Zinta's rebuttal, the Kerala Congress responded on X, stating that they had merely shared information reported by media outlets.

## RUSSIAN TOURIST DIES AFTER BEING ATTACKED BY SHARKS IN PHILIPPINE DIVING SPOT, ANOTHER DROWNS

**MANILA (TIP):** Two Russian tourists died when they were swept away by strong undercurrents while scuba diving in waters south of Manila, with one believed to have drowned and the other attacked by sharks, a Philippine coast guard official said February 28.

Two other Russian tourists managed to swim back safely to their dive boat Thursday off Verde Island, a popular diving destination in the province of Batangas, Philippine coast guard provincial commander Capt. Airland Lapitan said.

The four Russian tourists traveled by boat to the waters off Verde Island from the nearby town of Puerto Galera in Oriental Mindoro province with a Filipino dive instructor. While diving, the five were swept away by strong undercurrents, Lapitan said.

Two of the Russians managed to surface with the dive instructor but the two other Russians, who were identified as Ilia Peregudin, 29, and Maksim Melekhov, 39, went missing. The dive instructor and other divers in the area, along with Philippine coast guard personnel, immediately launched a search, according to Lapitan.

"The other Russian diver was found while being attacked by sharks. His right arm, unfortunately, had been severed and the sharks were moving around him," Lapitan told The Associated Press. "They somehow managed to pull him away." (AP)

# Israel and Hamas have begun negotiating next phase of Gaza ceasefire: Egypt

**KHAN YOUNIS (TIP):** Negotiations between Israel and Hamas on the next phase of the Gaza ceasefire began February 27, Egypt said, averting a collapse ahead of Saturday's expiration of the agreement's first phase.

Officials from Israel, Qatar and the United States started "intensive discussions" on the ceasefire's second phase in Cairo, Egypt's state information service said.

"The mediators are also discussing ways to enhance the delivery of humanitarian aid to the Gaza Strip, as part of efforts to alleviate the suffering of the population and support stability in the region," its statement said.

Phase 2 talks are meant to negotiate an end to the war, including the return of all remaining hostages in Gaza who are alive, and the withdrawal of all Israeli troops from the territory.

Return of remaining deceased hostages would happen in Phase 3.

According to Israel, there are 59 remaining hostages — 24 of whom are still believed to be alive.

It will be difficult to reconcile a deal with the war objectives of Israeli Prime Minister Benjamin Netanyahu, who has called for dismantling Hamas' governing and military capabilities. After suffering heavy losses in the war, Hamas has nonetheless emerged intact during the ceasefire, and the group says it will not give up its weapons.

Hours before talks began, an Israeli



official said the country would not withdraw from a strategic corridor in the Gaza Strip as called for under the ceasefire, a refusal that could severely complicate negotiations with Hamas and key mediator Egypt at a sensitive moment for the fragile truce.

Overnight, Hamas released the remains of four hostages in exchange for over 600 Palestinian prisoners, the last planned swap of the ceasefire's first phase.

U.S. President Donald Trump's Mideast envoy, Steve Witkoff, was expected in the region in the coming days.

Israeli official, speaking on condition of anonymity in line with regulations, said the army needed to remain in the so-

called Philadelphi corridor, on the Gaza side of the border with Egypt, to prevent weapons smuggling.

Hamas said any Israeli attempt to maintain a buffer zone in the corridor would be a "blatant violation" of the ceasefire agreement. Hamas says that sticking to the agreement is the only way for Israel to secure the release of dozens of hostages still held in Gaza.

Israel was supposed to begin withdrawing from the Philadelphi corridor on Saturday, the last day of the first phase, and complete it within eight days.

There was no immediate comment about the corridor from Egypt, which is opposed to any Israeli presence on the Gaza side of its border. (AP)

# Vatican says Pope Francis continues to improve but his prognosis remains guarded

**ROME (TIP):** Pope Francis continued to improve from double pneumonia February 27, the Vatican said, working from his hospital room and going to his private chapel to pray, though doctors said he needs more days of "clinical stability" before they revise their guarded prognosis.

The 88-year-old pope, who had part of one lung removed as a young man, was able to begin alternating high-flow supplemental oxygen, delivered by a nasal tube, with a mask in a sign of his improved respiratory condition, the Vatican said in a late update.

For the second day in a row, doctors avoided saying Francis was in critical condition. But they said that given the complexity of his lung infection, "further days of clinical stability are needed" before they revise their prognosis and decide he is out of danger.

Francis has been in Rome's Gemelli hospital since Feb. 14 after a bout of



bronchitis worsened.

He has shown steady, albeit slight improvements since a respiratory crisis

and kidney trouble over the weekend sparked fears for his life. The improvements, as he nears the two-week

mark on Friday, beat back speculation of an imminent death, resignation or conclave and signaled that he was still very much in charge.

Nevertheless, his near-term upcoming calendar of events was being changed: The Vatican cancelled a Holy Year audience scheduled for Saturday, and it remained to be seen if Francis would skip his Sunday noon blessing for the third week in a row. Longer term, Ash Wednesday loomed on the horizon March 5, the start of the church's Lenten season leading up to Holy Week and Easter, which this year falls on April 20.

In past years, when Francis has battled bronchitis and influenza in winter, he has had to cut back his participation in Ash Wednesday and Holy Week events, which call for the pope to be outdoors in the cold leading services, participating in processions and presiding over prayers in the solemn period in which the faithful commemorate Christ's crucifixion and resurrection. # North Korea appears to have sent more troops to Russia to back its war against Ukraine, Seoul says

**SEOUL (TIP):** South Korea's spy agency said February 26 that North Korea appears to have sent additional troops to Russia, after its soldiers deployed on the Russian-Ukraine fronts suffered heavy casualties.

The National Intelligence Service said in a brief statement it was trying to determine exactly how many more troops North Korea has deployed to Russia.

The NIS also assessed that North Korean troops were redeployed at fronts in Russia's Kursk region in the first week of February, following a reported temporary withdrawal from the area.

Ukrainian President Volodymyr Zelenskyy, in an address on Feb. 7, confirmed a new Ukrainian offensive in Kursk and said North Korean troops were fighting alongside Russian forces there.

North Korea has been supplying a vast amount of conventional weapons to Russia, and last fall it sent about 10,000-12,000 troops to Russia as well, according to US, South Korean and Ukraine intelligence officials.

North Korean soldiers are highly disciplined and well trained, but observers say they've become easy targets for drone and artillery attacks on



Russian-Ukraine battlefields due to their lack of combat experience and unfamiliarity with the terrain.

In January, the NIS said about 300 North Korean soldiers had died and another 2,700 had been injured. Zelenskyy earlier put the number of killed or wounded North Koreans at 4,000, though US estimates were lower at around 1,200.

Earlier Wednesday, South Korea's JoongAng Ilbo newspaper, citing unidentified sources, reported that an additional 1,000-3,000 North Korean soldiers were deployed to Kursk between January and February.

South Korea, the US and their partners worry that Russia could reward North Korea by transferring high-tech weapons

technologies that can sharply enhance its nuclear weapons program. North Korea is expected to receive economic and other assistance from Russia as well.

During talks in Saudi Arabia last week, Russia and the US agreed to start working toward ending the war and improving their diplomatic and economic ties. Ukrainian officials weren't present at the talks.

That marked an extraordinary shift in US foreign policy under President Donald Trump and a clear departure from US-led efforts to isolate Russia over its war in Ukraine.

Observers say North Korean leader Kim Jong Un could send more troops to Russia to win further Russian assistance before the war ends. (AP)

## FRANCE SAYS DISCUSSING ACCESS TO UKRAINE MINERALS FOR MILITARY USE

**PARIS (TIP):** France is in discussions with Ukraine to access its mineral wealth, including for military use, Defence Minister Sebastien Lecornu said February 27.

"We are discussing this question for France's needs," he told the Franceinfo broadcaster, a day before Ukrainian President Volodymyr Zelenskyy is to meet US President Donald Trump to finalise a deal on US access to Ukraine's mineral wealth.

The French-Ukraine talks started in October and were led by both countries' defence ministries, Lecornu said.

Unlike Trump, France was not seeking any payback in the form of minerals from Ukraine for aid granted in support of Kyiv's war against Russia, he said.

"We're not looking to be reimbursed," Lecornu said. "But our defence industry will need a certain amount of raw materials that are absolutely key to our own weapons systems. Not next year, but in the coming 30 or 40 years."

France needed to "diversify" its sources for such commodities, he said, without identifying the minerals he hoped to obtain from Ukraine.

He said Zelenskyy himself had launched the idea "of including minerals in his plan for victory" last autumn, starting discussions "not just with the United States, but also with France." (AFP)

## TWO MEN PUBLICLY FLOGGED 80 TIMES IN INDONESIA FOR SAME-SEX RELATIONS UNDER SHARIAH LAW

**BANDA ACEH (TIP):** Two men were publicly flogged in Indonesia's conservative Aceh province on February 27 after they were found guilty of sexual relations by a court operating under strict Islamic law.

While gay sex is not illegal elsewhere in Indonesia—the world's most populous Muslim-majority nation—it is outlawed in Aceh, which imposes a version of sharia, the Islamic legal code.

The flogging began before midday at a park in provincial capital Banda Aceh, with one man accused of instigating the relationship lashed 82 times and the second man 77 times. Both were caned with a rattan stick as dozens watched on, according to an AFP journalist present.

The men's sentences were reduced by three lashes for three months spent in detention.

In November, locals raided a rented room in Banda Aceh and found the two men—both students at a local university—together. They were taken to sharia police for the alleged crime of sexual relations. (AFP)

# 46 killed, 10 injured in Sudan military plane crash in residential area

**PORT SUDAN (TIP):** Forty-six people were killed when a Sudanese military transport plane crashed into a residential neighbourhood on the outskirts of Khartoum, the regional government said February 26.

The Antonov aircraft went down on Tuesday night near Wadi Seidna air base, one of the army's largest military hubs in Omdurman, northwest of the capital.

The army, which has been at war with the paramilitary Rapid Support Forces (RSF) since April 2023, said the plane crashed during takeoff, killing and injuring both military personnel and civilians.

"After a final tally, the number of martyrs reached 46, with 10 injured," the Khartoum regional government's media office said in a statement.

The army-aligned health ministry had previously reported at least 19 dead.

Witnesses described hearing a loud explosion and seeing several homes damaged in the area. The crash also caused power outages in nearby neighbourhoods.



The ministry said emergency teams rushed injured civilians, including children, to a nearby hospital.

A military source cited a technical malfunction as the cause of the crash, speaking to AFP on condition of anonymity because they were not authorised to comment to the media.

The crash came a day after the RSF

claimed responsibility for shooting down a Russian-made Ilyushin aircraft over Nyala, the capital of South Darfur. The paramilitary group said the plane was destroyed with its crew onboard.

The recent escalation follows significant advances by the army in central Sudan and the capital Khartoum in its multi-front offensive against the RSF. (AFP)

## 29 DEAD DUE TO HAIL, RAIN IN AFGHANISTAN: OFFICIALS

**HERAT, AFGHANISTAN (TIP):** Twenty-nine people died in two provinces in Afghanistan due to hail and heavy rain, officials said February 25.

"Twenty-one people were killed and six others were injured" because of hail in western Farah province, said Mohammad Israel Sayar, head of the province's Disaster Management Department.

The victims are members of two families who had gone for a picnic, he said.

In southern Kandahar, the local disaster management department said in a statement that eight people - including women and children - were killed in several locations due to heavy rain.

"Today, four women who were busy washing clothes were swept away by floodwaters... and only one woman survived," the statement said.

It added that a child drowned in Kandahar while a roof collapsed on a family killing one woman and three children. Among the poorest countries in the world after decades of war, Afghanistan is particularly exposed to the effects of climate change, which scientists say is spurring extreme weather.

It is ranked as the country sixth most vulnerable to climate change.

Drought, floods, land degradation and declining agricultural productivity are key threats, the UN development agency's representative in Afghanistan, Stephen Rodriques, said in 2023.

Flash floods in May last year killed hundreds and swamped swaths of agricultural land in Afghanistan, where 80 percent of people depend on farming to survive. (AFP)

## BANGLADESH ARMY CHIEF WARNS COUNTRY 'AT RISK' FROM INFIGHTING

**DHAKA (TIP):** Bangladesh's army chief on February 25 blamed infighting for deteriorating law and order, warning that the gains of the student-led revolution that toppled the government last August were at risk.

The South Asian nation has been struggling to stem a surge in violent crime, with the security forces arresting thousands this month targeting gangs allegedly connected to the party of ousted prime minister Sheikh Hasina. "If you can't move beyond your differences and continue meddling and fighting among yourselves, the independence and integrity of the country will be at risk - I warn you," said General Waker-Uz-Zaman, without singling out any group by name. "Since stakeholders are busy accusing each other, miscreants find the situation favourable. They believe they can get away with anything," he said at an army memorial event. "I just want to bring the country and the nation to a stable point and then take a vacation", he said. "After that, we will return to our barracks." (AFP)

# Bangladesh students who led anti-Hasina protests launch new party 'Ganatantrik Chhatra Sangsad'

27 FEB 2025

**DHAKA (TIP):** Bangladeshi students who played a key role in overthrowing the government last year have announced a new political party, the latest grouping in heated political jostling ahead of expected elections.

The new Ganatantrik Chhatra Sangsad, or Democratic Student Council, includes key organisers from the powerful Students Against Discrimination (SAD) group that spearheaded the uprising that overthrew iron-fisted former prime minister Sheikh Hasina in August.

Politics in Bangladesh are notoriously fractious and other students then accused them of undermining the revolution.

Disputes over representation led to physical clashes among members of the new group when its name was unveiled on February 26.

Other SAD leaders - including members who were included in the interim government that took over after Hasina fled to India - are expected to launch another separate party on Friday.

The Ganatantrik Chhatra Sangsad also includes students formerly allied to the youth wing of Hasina's Awami League.

"While accommodating students from



the Awami League, we ensured that none of them were involved in mass murder or torture during the revolution," Zahid Ahsan, a leader of the new group, told AFP.

"We are dedicated to protecting student rights," he said, adding they wanted to "uphold the spirit" of the mass movement that rallied to end Hasina's autocratic grip.

Hasina, who remains in self-imposed exile in India, has defied an arrest warrant from Dhaka to face charges that include accusations of crimes against

humanity.

More than 150 people were injured in clashes between rival student groups this month.

Muhammad Yunus, the Nobel Prize-winning microfinance pioneer who heads the caretaker government, has said that general elections will take place in late 2025 or early 2026.

The Bangladesh Nationalist Party, Hasina's long-time opponent, is widely expected to dominate the elections. (AFP)

## Pakistan security forces kill 10 terrorists in Khyber Pakhtunkhwa province

25 FEB 2025

**PESHAWAR (TIP):** Pakistani security forces killed 10 terrorists in an intelligence-based operation in Khyber Pakhtunkhwa province, the military's media wing said on February 24.

According to a statement from the Inter-Services Public Relations (ISPR), the operation took place in the Bagh area between Sunday night and early Monday, based on intelligence about terrorist activity.

Security forces engaged the militants, killing 10. A sanitisation operation is underway to clear any remaining threats in the area.

This operation follows two separate raids in Khyber Pakhtunkhwa's Dera Ismail Khan district, where security forces killed seven terrorists a day earlier.

Last week, 30 terrorists were killed in an operation in South Waziristan district.

Pakistan has witnessed a surge in terrorist activities, particularly in Khyber Pakhtunkhwa and Balochistan provinces, since the banned Tehreek-i-Taliban Pakistan (TTP) ended its ceasefire with the government in 2022.

A recent security report by the Islamabad-based think-tank Pak



Institute for Peace Studies highlighted a rise in terror attacks, with 2024 levels comparable to those of 2014.

While terrorists no longer control territories as they did in 2014, insecurity in parts of Khyber Pakhtunkhwa and Balochistan remains a major concern.

The report noted that 95 per cent of terror attacks in 2024 were concentrated

in these two provinces.

Khyber Pakhtunkhwa recorded the highest number of incidents, with 295 attacks.

Meanwhile, attacks by Baloch insurgent groups, particularly the Balochistan Liberation Army, surged by 119 per cent, with 171 incidents reported in Balochistan. (PTI)


# Women experience more neck pain than men

Shedding new light on how differently men and women experience pain, researchers, including one of Indian-origin, have found that women are 1.38 times more likely than men to report neck pain due to cervical degenerative disc disease.

Cervical degenerative disc disease is a common cause of neck pain. Symptoms include stiff or inflexible neck, burning, tingling and numbness. Pain is most prevalent when the patient is upright or moving the head.

The study by Meda Raghavendra and Joseph Holtman from Loyola University Chicago Stritch School of Medicine included 3,337 patients who were treated at Loyola's Pain Management Centre.

The findings were presented at



the annual meeting of the American Academy of Pain Medicine in Palm Springs, California, US.

The study adds to the growing body of research on the differences in which men and women experience pain.

Previous studies have found that females are more likely to be treated at pain clinics for chronic pain and that certain painful conditions, such as migraine headaches and fibromyalgia, are more common in women.

Various explanations have been proposed, including hormonal differences and the belief that men may be less willing to report pain.

Raghavendra and Holtman also conducted a similar study of patients who were treated at Loyola's Pain Management Centre for lumbosacral degenerative disc disease or lower back pain. The prevalence in females was slightly higher than the prevalence in males, but this difference was not statistically significant, the researchers said.

## Gulab Jamun

### Ingredients

For the Gulab Jamun Balls:

- 1 cup milk powder, ¼ cup all-purpose flour (maida), ¼ tsp baking soda, 2 tbsp ghee (clarified butter), ¼ cup milk (warm), Oil or ghee (for frying)

For the Sugar Syrup:

- 1 ½ cups sugar, 1 ½ cups water, 4-5 cardamom pods (crushed), 1 tsp rose water (optional), A few saffron strands (optional)



### Instructions:

- In a pan, mix sugar, water, and crushed cardamom.
- Bring to a boil and let it simmer for 5 minutes.
- Add rose water and saffron strands (if using). Keep warm.
- In a bowl, mix milk powder, flour, and baking soda. Add ghee and mix until crumbly.
- Slowly add warm milk and knead into a soft, smooth dough. Do not over-knead.
- Cover and let the dough rest for 10 minutes.
- Divide the dough into small, smooth balls (avoid cracks). Heat oil or ghee on low-medium heat.
- Fry the balls until golden brown, stirring gently for even cooking.
- Remove and drain excess oil.
- Add the fried jamuns to the warm syrup.
- Let them soak for at least 2 hours.

## Mix Vegetable Curry

### Ingredients:

For the Vegetables:

- 1 cup cauliflower florets, ½ cup carrots (chopped), ½ cup beans (chopped), ½ cup green peas, ½ cup potatoes (diced), ½ cup capsicum (chopped),

For the Gravy:

- 1 large onion (finely chopped), 2 tomatoes (pureed), 1 tbsp ginger-garlic paste, 2 tbsp cashew paste (soak cashews in warm water and blend), ½ tsp turmeric powder, 1 tsp red chili powder, 1 tsp coriander powder, ½ tsp garam masala, ½ tsp cumin seeds, 1 tbsp oil or ghee, ½ cup fresh cream (optional), Salt to taste, Fresh coriander for garnish

### Instructions

- Boil or steam the cauliflower, carrots, beans, potatoes, and peas until slightly tender.
- Keep the capsicum aside to be sautéed later.
- Heat oil or ghee in a pan, add cumin seeds and let them splutter.
- Add chopped onions and sauté until golden brown. Add ginger-garlic paste and cook until the raw smell disappears.
- Add tomato puree and cook until the oil separates. Mix in turmeric, red chili powder, coriander powder, and salt. Stir well.

- Add cashew paste and cook for another 2 minutes.
- Add the boiled vegetables and capsicum to the gravy. Mix well. Pour in ½ cup water (adjust consistency) and simmer for 5 minutes.

- 3. Add fresh cream and garam masala. Garnish with fresh coriander and serve hot.

**Nerve damage:** Diabetes can damage nerves responsible for the heart and blood vessels, affecting the heart's rhythm and the regulation of blood pressure.

**Increase blood pressure:** High levels of blood sugar can cause an increase in blood pressure, a significant risk factor for heart disease.

**Raise cholesterol:** It may push up the levels of cholesterol, which can lead to an increase in plaque creation within the arteries.

### TYPES OF HEART PROBLEMS CAUSED BY DIABETES

Individuals suffering from diabetes have an increased risk for a number of heart-related problems, such as:

## One sleepless night can impact immune function

A single sleepless night can significantly impact the immune system, leading to increased inflammation and a higher risk of chronic diseases. The study conducted by scientists at Kuwait's Dasman Diabetes Institute, published in The Journal of Immunology, sheds light on the specific mechanisms behind this phenomenon.

The study reveals alarming insights into the effects of sleep deprivation on the immune system. One key takeaway is that sleep deprivation triggers an increase in nonclassical monocytes (NCMs), immune cells that amplify inflammation.

Another is that it leads to inflammation regardless of weight, as these changes occur regardless of a person's weight, suggesting that even lean, healthy individuals may face inflammatory consequences from poor sleep. What's more? Sleep deprivation disrupts the balance between pro-inflammatory and anti-inflammatory immune responses, leading to a dominant pro-inflammatory state.

How were samples for the research collected? The research team recruited 237 healthy Kuwaiti adults across a spectrum of body weights and carefully monitored their sleep patterns using advanced



wearable activity trackers.

Though previous research established connections between obesity and poor sleep, this new study goes further by identifying specific immune mechanisms that may explain how sleep disruption contributes to chronic inflammatory conditions.

The implications of a sleepless night – from chronic disease risk and immune system vulnerability to cognitive and mood impairment – highlighted how we need to take proactive steps to prioritise sleep and mitigate the risks associated with poor sleep.



## Google Claims Its AI Tool Can Beat Math Olympiad Gold Medalists

Google has developed an artificial intelligence (AI) math system that can outwit human gold medalists at the International Mathematical Olympiad (IMO). AlphaGeometry2, the AI problem solver is capable of solving 84 per cent of geometry problems posed in the IMO where the gold-medal winners can only solve 81.8 per cent of the problems on average. IMO problems are known for their difficulty, and solving them requires a deep understanding of mathematical concepts -- something which the AI models had not been able to achieve up until now.

Engineered by DeepMind, AlphaGeometry managed to perform at the level of silver medallists in January last year when it was unveiled. However, a year later, Google claims the performance of its upgraded system had surpassed the level of average gold-medalists.

To enhance the system's abilities, the California-based company said it extended the original AlphaGeometry language to tackle harder problems involving movements of objects, and problems containing linear equations of angles, ratios, and distances.

"This, together with other additions, has markedly improved the coverage rate of the AlphaGeometry language on IMO 2000-2024 geometry problems from 66 per cent to 88 per cent."

Using its state-of-the-art Gemini AI tool, Google also improved the search process of AlphaGeometry2 to make it better at language modelling.

"The team also introduced the ability for the AI to reason by moving geometric objects around a plane - allowing it to move a point along a line to change the height of a triangle, for instance - and for it to solve linear equations."

Despite achieving an incredible 84 per cent efficiency rate in solving tricky math problems, Google said there is still room for improvement.

"Our domain language does not allow talking about variable number of points, non-linear equations and problems involving inequalities, which must be addressed in order to fully solve geometry," Google explained.

# Scientists call for open access to X's data for academic research

Researchers are calling for free access to social media platform X's data for academic analyses, insights from which can help understand trends in political engagement.

Efforts of a research group from Saarland University, Germany, were halted abruptly when X's owner Elon Musk blocked free access to X's data for academic research purposes in June 2023. The US-based entrepreneur acquired the platform, then known as Twitter, in October 2022.

The team wanted to know whether Twitter prioritised tweets from politicians from the right of the political spectrum between 2021 and 2023.

"It is simply not acceptable that access to these vast amounts of data is either unaffordable or provided so selectively that no meaningful analyses can be conducted," lead researcher Ingmar Weber, a professor of artificial intelligence (AI) and chair for societal computing at Saarland University, said.

The researchers called for implementation of legislation to ensure that academic researchers can regain access to social network data.

Over a period of two years, before the abrupt end, the team analysed tweets from 6,550 Twitter accounts associated with about 8,600 politicians from twelve countries known to have the highest user activity on X, including India, Argentina, Germany and the US.



The findings, published in the Journal of Quantitative Description: Digital Media, revealed no significant difference between the dissemination of content from left-leaning or right-leaning politicians across the countries analysed.

However, the team observed a considerable increase in the number of likes, a slight increase in the likes-per-retweet ratio and a significant reduction in the number of retweets post Musk acquisition.

"We believe that this is because early followers of a Twitter account are more politically engaged and tend to support content more actively. But as the political message gets spread to a broader audience, it becomes more likely that the number of likes will go up, while the retweet rate declines," study author and computer scientist Brahmani Nutakki, a PhD scholar at Saarland University, said.

However, the team faced challenges while analysing data, many of which were related to changes introduced between November 2022 and June 2023 following Musk's takeover -- one of them being the removal of rules prohibiting hateful conduct. The rules were aimed at preventing attacks on individuals.

"Changes to Twitter's functionality also resulted in changes in the user population, which made it difficult for us to attribute the changes we observed to a single specific cause," Nutakki said.

Further, "political content on the platform reached a wider audience following these changes," according to the study's findings.

"In the period before June 2023, we found no evidence of a significant difference in engagement patterns between users on the left and those on the right of the political spectrum," Weber said.

While there are media reports of instances such as posts of Republican politicians receiving greater engagement than those made by Democrats or hate content spiking, an academic analysis of X's data is needed for "continuous scrutiny".

"These worrying changes to social media platforms such as Twitter/X are jeopardising the democratic structures in many countries and require continuous scrutiny by academic researchers," Weber said.

Meta is reportedly exploring plans to build a massive data centre campus to support its artificial intelligence projects, with costs potentially exceeding \$200 billion, according to The Information. The company is said to be considering locations in Louisiana, Wyoming, and Texas, with senior executives visiting potential sites this month. Meta has been transparent about its growing commitment to the development of AI. However, a Meta spokesperson dismissed the report, stating that the company's data centre plans and spending have already been disclosed and that anything beyond that is "pure speculation."

Last month, Meta CEO Mark Zuckerberg revealed plans to invest up to \$65 billion in 2025 to expand AI infrastructure. In comparison, Microsoft is set to spend around \$80 billion in fiscal 2025 on data centres, while Amazon expects its 2025 investment to surpass the \$75 billion estimated for 2024.

The report comes days after Apple announced that it will invest \$500 billion in the US. That will cover its partnerships with thousands of



suppliers nationwide, direct employment, Apple Intelligence infrastructure, data centers, corporate offices, and Apple TV+ productions across 20 states. Apple plans to expand its data center capacity in North Carolina, Iowa, Oregon, Arizona, and Nevada.

Last month, OpenAI, along with SoftBank, launched a new company called the Stargate Project, which is aimed at "building a new AI infrastructure" through an ambitious investment of \$500 billion over the next

four years. OpenAI announced that the Stargate Project will begin deploying an initial \$100 billion immediately to build AI data centres for OpenAI in the United States.

Microsoft also made a similar commitment earlier this year in India. Microsoft Chairman and CEO Satya Nadella announced a \$3 billion investment in India over the next two years towards AI and cloud infrastructure and training initiatives. The announcement was made during Nadella's visit to India in January.

# Bitcoin slides under \$90,000, erasing some of the gains made under Trump

The price of bitcoin fell below \$90,000 and other cryptocurrencies saw large drops Tuesday morning, erasing some of the gains digital assets have made since President Donald Trump took office on a pro-crypto agenda.

Bitcoin, the world's most popular cryptocurrency, was trading at about \$89,000 as the U.S. stock market opened. That's down from about \$106,000, which was the price around Trump's inauguration. The decline in bitcoin and other crypto assets accelerated after a report showed a bigger-than-expected drop in consumer confidence for this month.

Cryptocurrency is highly volatile, and prices can change rapidly. Even with Tuesday's drop, bitcoin is still up significantly since Trump won last year's election. Supporters said the price drops represent a good investment opportunity.

"Buy the dips!!!" Eric Trump, the president's son, said on the social media platform X. He replaced the letter B with the symbol for bitcoin.

It's been a mixed bag for the cryptocurrency industry in recent weeks. The president and pro-crypto members of Congress have promised to usher in a golden age for the industry and pledged quick action to craft friendly regulations. And in recent weeks, regulators at the Securities and Exchange Commission have signaled plans to drop enforcement actions against key industry players, like Coinbase and Robinhood.

But a large hack of a major cryptocurrency exchange -- one of the biggest thefts of all time -- and a major scandal involving the president of Argentina and a meme coin have highlighted some of the vulnerabilities in a relatively still nascent industry.

Last week the Dubai-based cryptocurrency exchange Bybit announced it was a victim of a sophisticated hack that stole about \$1.5 billion worth of digital currency. A number of security researchers believe North Korea, which authorities have blamed for several other major crypto hacks, was behind the theft.

Argentine President Javier Milei is facing a corruption



probe into his promotion of a meme coin, called LIBRA, whose price soared then quickly crashed after Milei posted about it on X. Milei has distanced himself from the meme coin and denied any wrongdoing.

Meme coins are a highly speculative form of cryptocurrency that are mostly minted as jokes and have no intrinsic value but can sometimes soar in price.

One of the crypto developers involved in the LIBRA coin said meme coins are essentially a rigged game that benefits a small group of people at the expense of retail investors in a recent interview with an independent journalist.

That developer, Hayden Davis, also revealed he was involved in the launch of First Lady Melania Trump's meme coin just before her husband took office. The Melania meme coin was trading at about 90 cents on Tuesday, down from more than \$13 when it first launched. The president also helped launch a meme coin just before he took office that's seen a similar price trajectory.

Solana, a major cryptocurrency that's a key player in the meme coin ecosystem, has seen its price roughly cut in half since Trump's inauguration.

## Amazon India hit with \$39 million penalty for apparel trademark violation

The Delhi High Court has ruled against Amazon, directing one of its units to pay \$39 million, which is over Rs 337 crores, in damages for violating trademark rights.

The lawsuit was filed by Lifestyle Equities, the owner of the Beverly Hills Polo Club (BHPC) horse trademark. It claimed that Amazon India was selling apparel with a similar logo at lower prices. The court mentioned that stated that the infringing brand belonged to Amazon Technologies and was sold on Amazon India platform.

Legal experts regard this as a landmark ruling in Indian trademark law against a US company. The Delhi High Court, in its 85-page order, stated that the logo on the infringing product was almost identical to BHPC's trademark and issued a 'permanent injunction' against Amazon.

The court said that Amazon had indulged in deliberate and wilful infringement.

It also mentioned that Amazon runs its apparel trade under the 'SYMBOL' brand, and the infringing horse logo was used on 'Symbol' branded apparel.

It is pointed out that Amazon is widely recognised as one of the key players in the e-commerce industry. As a result, it has the capacity and resources to utilise its strong presence to promote its own products and also those which it chooses to promote.

# Apple to invest in Indonesia in bid to end iPhone sales ban in country

One of the world's largest smartphone manufacturers, Apple, has signed an agreement with Indonesia to invest \$1 billion in the southeast Asian nation in a bid to end the ban on iPhone sales in the country.

The agreement was announced by Industry Minister Agus Gumiwang Kartasasmita in a media briefing in Jakarta on Wednesday, as reported by Bloomberg Technoz. The process to issue a sale permit to Apple will begin, which will allow the company to sell its latest iPhone 16 series models in Indonesia.

Indonesian government had refused to issue a sale permit to Apple in October. The country's government had cited Apple's failure to comply with domestic manufacturing requirements for smartphones and tablets. Apple had then promised to invest \$1 billion in Indonesia, which President Prabowo Subianto had asked his ministers to accept.

The ban was upheld by Indonesia's Industry Ministry in January as it sought better terms to the agreement. Apple agreeing to the country's terms will help Indonesia in attracting local



manufacturing and boosting government had previously said that investments by a foreign company. The Apple had invested only about \$95

million in Indonesia.

The agreement also comes at an opportune time for Prabowo, according to Bloomberg. The optics of a US tech giant yielding to his administration could be used to boost his domestic standing, which has taken a hit following multiple policy U-turns that have generated confusion. On top of that, his plan for sweeping spending cuts that threatened jobs and scholarships triggered days of protests last week.

For Apple, the deal gives it access to Indonesia's massive consumer market at a time when sales in China have slowed. Though Apple ranks outside the top five smartphone brands in Indonesia, the country's population of 278 million people — more than half of whom are under the age of 44 and tech-savvy — is too good an opportunity to miss.

The agreement includes the establishment of a plant on the island of Batam to produce AirTags, a device that allows users to track their luggage, pets or other belongings, Bloomberg Technoz cited the minister as saying. Apple is bringing on board one of its significant suppliers, Luxshare Precision Industry Co., to operate the plant.


# Sikh History This Week

## FEBRUARY 28 TO MARCH 6

### 28th February



1712: Bahadur Shah died. A war broke out among his sons. Baba Gurbakhash Singh, alias Banda Bahadur, took advantage of the situation and appeared once again in the plains. His first victory was against Islam Khan, the Governor of Lahore. The next to fall was the zone of Sirhind. But this victory was again, short lived.



1921: Gurudwara Rori Sahib was forcibly taken over and brought under the control of SGPC.

1924: All India Congress passed resolution, condemning the killings of Sikhs devotees at Gangsar, Jaito.

### 1st March

1923 Assa Singh of Phakrudi was arrested from Kiratpur Sahib.

1925 15th Shahidi Jatha of 500 valiant Akali Satyagrahies started their march from Sri Akal Takhat, Amritsar, towards Gangsar, Jaito.

### 2nd March



1909: Kapur Singh, the Sikh scholar, statesman and

administrator, was born at Mannan Kalan Chakk. The Sikh scholar, statesman and administrator, was born on 2 March 1909 at Mannan Kalan Chakk. His parents (father: Sardar Didar Singh, and mother: Harman Kaur) were upper middle class peasants at Lyallpur, now known as Faisalabad in the modern-day Pakistan. Young Kapur Singh spent his early childhood at Faisalabad where the environment was saturated with the Sikh renaissance movement spearheaded by the Singh Sabha ideology.

1928: Nehru Committee accepted Sikhs right to bear Kirpan.

### 3rd March

1644 Sixth Patshah, Guru Hargobind Ji departed from this planet at Kirtapur. This is the actual date of Joti Jot, although it is observed on a different date by Guru Khalsa Panth.

1762 Ahmad Shah Abdali, upon reaching Lahore, displays the heads of Sikhs by hanging them on doors and walls.

1921 Speaking at Shaheedi Diwan, Gandhi sought to integrate the Gurudwara reform movement into the national movement against colonialism. He wanted them "to dedicate their martyrdom to Bharat mata and believe that the Khalsa can remain free only in a free India." With this event Gandhi, in his immitable style took politics into religion which the Central Sikh League, a political organisation, had carefully avoided by leaving the reform movement to the SGPC. Gandhi was a "Hindu holy man with political cloak" in quest for power. Siks weren't immediately taken in. However, the damage had been done. Gandhi had sown the seeds of division in the Tat Khalsa which sprouted only a few months later.

1923 Dacoity at Jamser railway station ius committed by the Babbar Akalis.

1924 3rd Shahidi Jatha of 500 valiant Akali Satyagrahies, led by Sardar Santa Singh of Chuck No. 133, Sargodha, courted arrest at Jaito.

1947 Muslim League asked to form government in the Punjab. Sikh leaders met in the chamber of Assembly, Lahore. A mammoth crowd raised provocative slogans. At this point, Master Tara Singh came out, unleashed his sword and said "we shall lay down our lives but won't concede Pakistan." With this, it became famous that Master Tara Singh had cut off the Pakistan Flag. In actuality, Master Tara Singh did not tear any flag. However, being a fiery speaker, it was perceived that he did.

### 4th March

1716 Marked the killing of Sikhs in Delhi, under the protection of Sarabrah Khan. 100 Sikhs were killed on the first day.

1953 Akali led government of PEPSU province dismissed without any ground.

1988 Jasbir Singh Rode, a nephew of Jarnail Singh



Bhindrawalae, who had been nominated as the Chief Granthi of Sri Akal Takhat, was won over by Rajiv Gandhi, while he was in jail. Under a secret agreement he was released on this day. He tried to confuse the Sikh masses as planned but the Sikh nation rejected him in the same manner as Ragi Darshan Singh. He called a meeting of Sarbat Khalsa at Talwandi Sabo on April 13, 1988. Even this congregation declated that the Sikh nation would not compromise its freedom.

### 5th March

1716 Marks the begining of systematic execution of 740 Sikh soliders. After their surrender at the fort of Gurdas Nangal, Banda Singh Bahadur, the valiant Sikh General and his 740 solidiers were taken to Delhi. From Mar. 5 through Mar. 11, these solidiers along with Banda Bahadur were executed in groups of 100. They were given the option to adopt Islam and escape execution. However, each one of these solidiers refused the offer and instead willingly accepted shahadet with unflinching faith and fortitude.

1748 Khalsa Panth gathered at Anandpur Sahib for Holla Mehla observations and resolved to gather in Amritsar for Vaisakhi celebrations.

1892 The foundation stone for Khalsa College, a Shiromani education institution for Sikhs, was laid in Amritsar by J.B. Loyal. Prof. Gurmukh Singh was instrumental its establishment after more than a decade of tireless efforts. The College Council was controlled by its Vice-President Sit Attar Singh Bhadaur with Jawahar Singh serving as General Secretary.

1921 Gurudwara Sach Khand (Chuharkana) Sahib was forcibly taken over and brought under the control of SGPC.

1948 Khalsa Panth gathered at Anandpur Sahib for Holla Mehla observations and resolved to gather in Amritsar for Vaisakhi celebrations.

1955 Punjabi Suba Conference was held at Patiala.

1971 Elections to Indian Lower House were held. Akali Dal won 1 of the 13 Punjab seats.

### 6th March

1752 The cooperation between Sikhs and Mir Mannu snapped as a result of Kaura Mal's death. This was evident from action during Abdali's third invasion. The Sikhs under the patronage of Diwan Kaura Mal, a Khulasa Sikhs, had cooperated with Mir Mannu. henceforth, Mir Mannu as a nominee of Afghans pursued the policy of extirpating Sikhs. If nothing else, their women and children were taken to Nakhas, Lahore, in hundreds, and were subjected to gruesome torture and martyred. In 18 months, he killed about 30,000 Sikhs. The peasentry crushed, because of the Afghan depredations and roving provincial troops in search of the Sikh families, joined the Khalsa fold in large numbers who offered them protection.

1752 Diwan Kodha Mal, also known as Mitha Mal, died while fighting in Lahore.

1834 Peshawar occupied by Sikhs. Ranjit Singh sent a force under Hari Singh Nalwa, Ventura and Court under nominal command of Prince Nau Nihal Singh. Pathan chiefs sent their families away as they were aware of the duplicity Of Shah Shujah and Ranjit Singh's intention to occupy Peshawar. They agreed to enhance the tribute but the Sikh army occupied Peshawar on the pretext that the Prince wanted to see the town and the Pathan chiefs left the city. Hari Singh Nalwa was appointed Governor of Peshawar along with the Governorship Of Hazara. British did not appreciate Sikh occupation of Peshawar. Sikh coins struck from Peshawar.

1921 Gurudwara Manak Sahib was forcibly taken over and brought under the control of SGPC.

These texts emphasize the power of divine feminine energy in bringing success and removing obstacles.

## When is Nanda Vrat Observed?

Nanda Vrat is usually observed on Ashtami Tithi (eighth day) of the lunar month, especially during Shukla Paksha (waxing phase of the moon). The vrat is particularly significant when it falls during Navaratri, the nine-day festival dedicated to Goddess Durga.

Many devotees also perform this vrat

for 16 consecutive weeks to seek divine blessings.

## How to Perform Nanda Vrat?

- Wake up early in the morning, take a bath, and wear clean clothes.
- Maintain a clean environment and set up a small altar or puja space.
- Arrange an idol or image of Goddess Nanda (or Durga/Parvati) on a clean altar.
- Gather Puja Samagri (Essential Items)
- Fresh flowers (preferably red or yellow)
- Fruits and sweets
- Incense sticks (Agarbatti)
- A lamp (Diya)
- Coconut and betel leaves
- Kumkum, turmeric, and

sandalwood paste

- Panchamrit (a mixture of milk, curd, honey, sugar, and ghee)
- Sacred thread (kalawa)

## Step-by-Step Rituals

- Sankalp (Taking the Vow)
- Sit in front of the deity and take a vow (sankalp) to observe the vrat with devotion.
- Mentally pray for the fulfillment of your desires.
- Offer Prayers and Aarti
- Light a lamp and incense sticks.
- Offer fresh flowers, fruits, and sweets to the goddess.
- Recite mantras such as:  
"Om Dum Durgaye Namah"  
"Om Hreem Nanda Devyai Namah"
- Sing the Nanda Vrat Katha (story of the vrat) if available.
- Perform abhishekam (ritual bathing) of the idol with Panchamrit.
- Offer coconut, sweets, and food prepared for the goddess.
- Giving food or donations to the poor is considered highly auspicious.

## Fasting Guidelines

- The fasting can be nirjala (without water) or phalahar (fruits and milk only), depending on the devotee's ability.
- Some people consume only one meal in the evening after completing the puja.
- Avoid consuming non-vegetarian food, alcohol, onions, and garlic.

## Evening Aarti and Conclusion of the Vrat

- Perform an evening aarti with diya and bhajans.
- Conclude the vrat by distributing prasada (sanctified food) among family members and devotees.

## Benefits of Observing Nanda Vrat

- Blessings of Goddess Nanda
- Removes obstacles and brings peace, happiness, and prosperity.

## Marital Bliss

- Women seeking a good husband or wishing for harmony in their married life observe this vrat with devotion.

- Those facing financial troubles or business losses observe this vrat for success and wealth.

Yesterday, EAM Jaishankar called on the President of the European Commission, Ursula von der Leyen, and lauded her views on reenergizing India's engagement with Europe.

"Pleased to call on @EU\_Commission President @vonderleyen today in Delhi. Appreciate her thoughts on reenergizing India's engagement with Europe. The wide-ranging participation of Indian Ministers and EU College of Commissioners during this visit stands testimony to the importance we place on deeper India-EU ties," Jaishankar said in a post on X.

The European Commission President is on a two-day bilateral visit to India, accompanied by members of European College of Commissioners. Union Minister of State for Health and Family Welfare Anupriya Patel received Ursula von der Leyen at the airport.

Upon her arrival in Delhi, European Commission President in a post on X wrote, "Touchdown in Delhi with my team of Commissioners. In an era of conflicts and intense competition, you need trusted friends. For Europe, India is such a friend and a strategic ally. I'll discuss with @narendramodi how to take our strategic partnership to the next level."

This is Ursula von der Leyen's third visit to India. She previously visited India for a bilateral official visit in April 2022 and to attend the G20 Leaders' Summit in September 2023. PM Narendra Modi and President Ursula von der Leyen have also met regularly on the sidelines of multilateral meetings. (Source: ANI)

## Trump plans tariffs on Mexico and...

The prospect of escalating tariffs has already thrown the global economy into turmoil, with consumers expressing fears about inflation worsening and the auto sector and other domestic manufacturers suffering if Trump raises import taxes. But Mr. Trump has also at times engaged in aggressive posturing only to give last-minute reprieves, previously agreeing to a 30-day suspension of the Canada and Mexico tariffs that were initially supposed to start in February.

The threat of tariffs frightened the stock market with the S&P 500 index falling 1.6% on Thursday. The S&P 500 is now just 1.4% higher than it was after Mr. Trump won the election in November, giving up almost all of the gains that the president once cited as evidence of an economic revival.

Asked Thursday about the fact that tariffs are largely paid for consumers and importing companies, Mr. Trump dismissed any concerns by saying: "It's a myth." It's possible for a stronger U.S. dollar to offset some of the costs of tariffs, but Trump's statement goes against most economic modeling given the breadth of his planned taxes.

Mr. Trump intends to put 25% tariffs on imports from Mexico and Canada, with a lower 10% tax on Canadian energy products such as oil and electricity. The move, ostensibly about drug trafficking and immigration, led Mexico and Canada to respond by emphasizing their existing efforts to address these

issues. Canada created a fentanyl czar, and Mexico sent 10,000 members of its National Guard to its border with the United States.

Mexican President Claudia Sheinbaum said Thursday that she hoped to speak with Mr. Trump after the Cabinet-level meetings occurring in Washington this week. Mexico's Foreign Affairs Secretary Juan Ramón de la Fuente was scheduled to meet with Secretary of State Marco Rubio on Thursday afternoon.

Mr. Trump, "as you know, has his way of communicating," Ms. Sheinbaum said. But she said that her government would stay "cool-headed" and optimistic about an agreement coming together to avoid the tariffs.

"I hope we are able to reach an agreement and on March 4 we can announce something else," she said.

She said Mexico's security chiefs were discussing intelligence sharing with their American counterparts that would allow for important arrests in the U.S. On the economic front, she said Mexico's goal is to protect the free trade pact that was negotiated during the first Trump administration between Mexico and the United States. That 2020 deal, which included Canada, was an update of the North American Free Trade Agreement from 1994.

Canadian Prime Minister Justin Trudeau said his country has invested more than 1 billion Canadian dollars to improve border security, adding that his government's ministers and officials are also in Washington this week.

"There is no emergency for the United States at the border with Canada when it comes to fentanyl, and that is exactly what we are demonstrating at this time," Mr. Trudeau said in Montreal. "If the United States goes ahead and imposes tariffs, we already shared the details of our plan. We have \$30 billion worth of U.S. products that will be subject to tariffs. And \$125 billion of tariffs that will be applied three weeks later. But we don't want to be in that position."

Mr. Trump did impose a 10% tariff on China for its role in the manufacturing of chemicals used to make fentanyl, and that tax would now be doubled, according to his social media post.

On Thursday, China's Commerce Minister Wang Wentao wrote to Jamieson Greer, the newly confirmed U.S. trade representative, that differences on trade should be resolved through dialogues and negotiations. The 25% tariffs on Mexico and Canada would amount to a total tax increase on the U.S. public of somewhere between \$120 billion to \$225 billion annually, according to Jacob Jensen, a trade policy analyst at the American Action Forum, a center-right think tank. The additional China tariffs could cost consumers up to \$25 billion.

The potential for higher prices and slower growth could create political blowback for Mr. Trump, who promised voters in last year's presidential election that he could quickly lower the inflation rate, which jumped during Democratic President Joe Biden's term. But, Mr. Trump also campaigned on imposing broad tariffs, which he plans to launch on April 2 by resetting them to match the taxes that he determines are charged by other countries on American goods.

"The April Second Reciprocal Tariff date will remain in full force and effect," Mr. Trump said as part of his new social media post.

In an interview with News Nation, Kevin Hassett, the director of the White House National Economic Council, said progress by Mexico and Canada on fentanyl "was not as impressive as the president had hoped." There are significant differences between Canada and Mexico on the scale of drug smuggling. U.S. customs agents seized 43 pounds (19.5 kilograms) of fentanyl at the Canadian border during the last budget year, compared with 21,100 pounds (9,570 kilograms) at the Mexican border.

Mr. Hassett stressed that the reciprocal tariffs would be in addition to the ones being placed on Canada and Mexico.

Mr. Trump indicated Wednesday that European countries would also face a 25% tariff as part of his reciprocal tariffs. He also wants separate tariffs on autos, computer chips and pharmaceutical drugs that would be levied in addition to the reciprocal

tariffs.

The President already announced that he's removing the exemptions on his 2018 steel and aluminum tariffs, in addition to planning taxes on copper imports.

The prospect of a broader trade conflict should other nations follow through with their own retaliatory tariffs is already spooking U.S. consumers, potentially undermining Trump's promise to unleash stronger economic growth.

The Conference Board reported on Tuesday that its consumer confidence index had dropped 7 points to a reading of 98.3. It was the largest monthly decline since August 2021, when inflationary pressures began to reverberate across the United States as the economy recovered from the coronavirus pandemic. Average 12-month inflation expectations jumped from 5.2% to 6% in February, the Conference Board noted.

"There was a sharp increase in the mentions of trade and tariffs, back to a level unseen since 2019," said Stephanie Guichard, a senior economist at the Conference Board. "Most notably, comments on the current administration and its policies dominated the responses." (Source: AP)

## Former defense chiefs denounce...

"We are deeply alarmed by President Trump's recent dismissals of several senior U.S. military leaders," the letter opens. "We write to urge the U.S. Congress to hold Mr. Trump to account for these reckless actions and to exercise fully its Constitutional oversight responsibilities."

Among those ousted on Friday were Gen. Charles Q. Brown Jr., the Pentagon's top officer; Adm. Lisa Franchetti, the head of the Navy; Gen. James Slife, the Air Force's vice chief of staff; and the top military lawyers for the Army, Navy and Air Force. Trump's defense secretary, former Fox News personality Pete Hegseth, also removed his senior military assistant, Air Force Lt. Gen. Jennifer Short. The head of the Coast Guard, Adm. Linda Fagan, was fired the day after Trump's inauguration.

The Trump administration has sought to downplay the dismissals, noting that previous presidents also have fired prominent generals. Those dismissals, however, typically had a proximate cause.

"The President offered no justification for his actions, even though he had nominated these officers for previous positions and the Senate had approved them," the letter says. "These officers' exemplary operational and combat experience, as well as the coming dismissals of the Judge Advocates General of the Army, the Navy, and the Air Force, make clear that none of this was about warfighting." Brian Hughes, a spokesman for the White House's National Security Council, said in a statement Thursday that Trump is the commander in chief and his actions are "well within" his authority - a point that most critics have not disputed.

## US judge halts Trump Administration's...

Republican President Donald Trump and billionaire Elon Musk, who oversees the so-called Department of Government Efficiency, are spearheading an unprecedented effort to shrink the federal bureaucracy, including through job cuts.

Those efforts have resulted in a fierce pushback from Democrats, unions and federal workers, who argue the job cuts are illegal and could compromise government functions. Already, the administration has been forced to recall some personnel in critical roles. But Trump has backed Musk to the hilt and has embraced Musk's goal of slicing \$1 trillion from the nation's \$6.7 trillion budget.

Budget experts say Musk, the CEO of SpaceX and Tesla, is unlikely to reach his target by trimming jobs and reducing waste and fraud, and may have to slash government programs, including benefits.

On Thursday, hundreds of probationary workers at the National Oceanic and Atmospheric Administration, which conducts climate science, were notified they were being let go, according to a source familiar with the situation.

# Western Ghats: A paradise of hill stations, waterfalls and wildlife

Hosting a huge number of tourists every year, hill stations like Ooty, Mahabaleshwar, Lonavala, Khandala, Munnar, Ponnudi, Coonoor and Vythiri are all situated in the Western Ghats. Other places of tourist interest like Kodaikanal, Lovedale, Mattupetty, Meghamalai and Valparai are also located in this region.

The Western Ghats mountain range is itself a major attraction in India along with its high hills, deep valleys, mountain grasslands, dense and rain forest. The 1,600 km long majestic Mountains of Western Ghats is one of the eight hottest biological diversity hotspots in the world. Western Ghats is one of the UNESCO World Heritage Site in India and paradise of various species of Flora and Fauna. Most of them are endemic to the region.

## Hill Ranges

The Western Ghats contains major hill ranges starting from Sahyadhri mountain ranges in Maharashtra Nilgiris hill ranges in Tamil Nadu. These hill ranges are home to most popular hill stations such as Ooty, Mahabaleshwar, Madikeri and the most famous Munnar. Famous hills of Western Ghats are Sahyandhris, Nilgiris, Palani Hills, Anaimalai Hills and Cardamom Hills.

## Mountain Peaks

The hill ranges of Western Ghats are home to some of the highest mountain peaks of India. Anamudi or the Elephant Head is the highest peak of the Western Ghats with an elevation of 2,695 m (8,842 ft) located in the Indian state Kerala. The Anamudi mountain peak is also the highest point in India outside the great Himalaya-Karakoram mountain ranges. Other highest peaks of the Western Ghats are Meesapulimala, Doddabetta in Nilgiris hills, Kalsubai in Maharashtra and Mullayanagiri in Karnataka.

## Forest

Western Ghats offers four type of tropical and subtropical forest ecoregions -North and South Western moist deciduous forests, North and South Western montane rain forests. The north part of the hill ranges is drier than the southern part of ranges and dominantly by teak. South Western Ghats montane rain forests offers very rich ecologic region for the wide variety of flora and fauna species. The wild forest of Western Ghats are distributed as National Parks, Wildlife Sanctuary, Tiger reserve, biosphere reserves and many protected areas.

## Grasslands

The mountain valley of Western Ghats covered with shola-grassland, evergreen and semi-evergreen vegetation, and montane grasslands. Shola grassland are mainly found in the valleys and different



from montane grassland. The shola forest and grassland complex are distributed in the higher altitude hills of Nilgiris, Biligiriranga Hills and Agasthyamalai Hills.

## Flora

The dense forests and evergreen valleys of rolling Sholas grassland of Western Ghats mountain ranges offers rich ecologic area for number of flowering plants. The major species of Flora in Western Ghats are present in the sholas of the Nilgiri Hills. Main species of flowering plants found here are Michelia niligirica, Eugenia, Toona

ciliata, Schefflera and Michelia. Kas Plateau in Maharashtra is best place to know about the numerous species of flowering plants also known as the valley of flowers of Western Ghats.

## Lakes

The Western Ghats region has many natural and man made lakes. The famous lakes are beautiful Vembanad lake, Ooty avalanche lake, Pookode lake, Letchmi Elephant and Berijam Lake. The major reservoirs includes famous Krishna Raja Sagara, Mettur Dam, Koyna Dam, Parambikulam Dam and Linganamakki Dam. Arabian Sea also offers beautiful

lakes in Kerala known as backwaters of Kerala, one of the major tourist attraction.

## Waterfalls

The majestic mountain ranges of Western Ghats form one of the four watersheds and feed the perennial rivers of India. Major rivers of Western Ghats are the Godavari, Krishna, Thamiraparani and Kaveri others tributaries to these long rivers, flow to the east and fall into the Bay of Bengal. During the monsoon season these rivers offers some of the spectacular waterfalls in India such as the most stunning Jog Falls by Sharavathi River, Astonishing Athirappilly Falls by Chalakudy river, Kunchikal Falls, Sivasamudram Falls, Unchalli Falls and famous Meenmutty Falls.

## Fauna

The Fauna of Western Ghats is very unique and many of them are endemic to the mountains of monsoon only. Wildlife includes 139 species of mammal, Reptiles, Amphibians and at least 508 species of birds. The endemic animals of Western Ghats are Malabar large-spotted civet, endangered Lion-tailed macaque and the beautiful black panther. Couple of new species are also found here in the last few year one of the them is pogeyan cat, A wild cat which is larger than a leopard but smaller than a Tiger, More information about the pogeyan cat is yet to collect.

## National Parks

There are 13 National parks situated in the Western Ghats along with two biosphere reserves, several wildlife sanctuaries and many Reserve Forests. These protected areas are home to thousands of animal species including globally threatened and critically endangered species. Famous National parks are deciduous forests of Bandipur National Park, Silent Valley National Park, Periyar National Park and Eravikulam National Park. The rainforest of majestic mountain is full of natural beauty and one of the must see place in India.

## Avifauna

The Avifauna of western ghats are endemic to the forest and great hills, birds such as beautiful Rufous-breasted Laughingthrush, Nilgiri Flycatcher, Malabar Parakeet and Malabar Grey Hornbill are some of the most beautiful birds of Western Ghats. The evergreen forests of Kerala and deciduous forest Karnataka provided wild foods and natural habitats to these wild birds. The mountain ranges have many bird sanctuaries as well and offers one of the best place for bird watching in India.

## FEBRUARY 26




February 26, 1994 - Political foes of Russian President Boris Yeltsin were freed by a general amnesty granted by the new Russian Parliament.

Birthday - American frontiersman "Buffalo Bill" Cody (1846-1917) was born in Scott County, Indiana. He claimed to have killed over 4,000 buffalo within 17 months. He became world famous through his Wild West show which traveled throughout the U.S. and Europe for 30 years.

## FEBRUARY 27

February 27, 1950 - The 22nd Amendment to the U.S. Constitution was ratified, limiting the president to two terms or a maximum of ten years in office.

February 27, 1991 - In Desert Storm, the 100-hour ground war ended as Allied troops entered Kuwait just four days after launching their offensive against Saddam Hussein's Iraqi forces.



Birthday - American poet Henry Wadsworth Longfellow (1807-1882) was born in Portland, Maine. Best known for Paul Revere's Ride, The Song of Hiawatha, and The Wreck of the Hesperus.

## FEBRUARY 28

February 28, 1844 - During a demonstration of naval fire power, one of the guns aboard the USS Princeton exploded, killing several top U.S. government officials on the steamer ship, and narrowly missed killing President John Tyler.



February 28, 1986 - Swedish Prime Minister Olof Palme (1927-1986) was assassinated in Stockholm while exiting a movie theater with his wife.

February 28, 1994 - NATO conducted its

first combat action in its 45 year history as four Bosnian Serb jets were shot down by American fighters in a no-fly zone.

## MARCH 1



March 1, 1932 - The 20-month-old son of aviation pioneer Charles A. Lindbergh was kidnapped from his home in Hopewell, New Jersey. The Lindberghs then paid a \$50,000 ransom. However, on May 12, the boy's body was found in a wooded area a few miles from the house.


March 1, 1961 - President John F. Kennedy established the Peace Corps, an organization sending young American volunteers to developing countries to assist with health care, education and other basic human needs.

March 1, 1974 - Seven former high-ranking officials of the Nixon White House were indicted for conspiring to obstruct the investigation into the Watergate break-in. Among those indicted; former chief of staff H.R. Haldeman, former top aide John Ehrlichman, and former attorney general John Mitchell.

Birthday - American band leader Glenn Miller (1904-1944) was born in Carilinda, Iowa. His music gained enormous popularity during the 1940's through recordings such as Moonlight Serenade and String of Pearls. On December 15, 1944, his plane disappeared over the English Channel while en route to Paris where he was scheduled to perform.

## MARCH 2

March 2, 1943 - During World War II in the Pacific, a Japanese convoy was attacked by 137 American bombers as the Battle of Bismarck Sea began. The convoy included eight destroyers and eight transports carrying 7,000 Japanese soldiers heading toward New Guinea. Four destroyers and all eight transports were sunk, resulting in 3,500 Japanese drowned, ending Japanese efforts to send reinforcements to New Guinea.



Birthday - American soldier and politician Sam Houston (1793-1863) was born in Rockbridge County, Virginia. As a teenager he ran away and joined the Cherokee Indians who accepted him as a member of their tribe. He later served as a Congressman and Governor of Tennessee. In 1832, he became commander of the Texan army in the War for Texan Independence, defeating the larger Mexican army in 1836 at the Battle of San Jacinto. He then served as Senator and Governor of the new state of

Texas but was removed in 1861 after refusing to swear allegiance to the Confederacy.

## MARCH 3

March 3, 1913 - A women's suffrage march in Washington D.C. was attacked by angry onlookers while police stood by. The march occurred the day before Woodrow Wilson's inauguration. Many of the 5,000 women participating were spat upon and struck in the face as a near riot ensued. Secretary of War Henry Stimson then ordered soldiers from Fort Myer to restore order.



Birthday - Railroad car builder George Pullman (1831-1897) was born in Brocton, New York. He improved railroad sleeping accommodations, developing the folding upper berth and lower berth designs. His company went on to become the biggest railroad car building organization in the world.

Birthday - Telephone inventor Alexander Graham Bell (1847-1922) was born in Edinburgh, Scotland. Bell and his father were involved in teaching deaf persons to speak. Bell developed an interest in the vibrating membrane as a method of electrically transmitting sounds. His very first sentence spoken on the newly invented telephone on March 10, 1876, was to his assistant, "Mister Watson, come here, I want you."

## MARCH 4



March 4, 1830 - Former President John Quincy Adams returned to Congress as a representative from Massachusetts. He was the first ex-president ever to return to the House and served eight consecutive terms.

March 4, 1933 - Newly elected President Franklin D. Roosevelt took office and delivered his first inaugural address attempting to restore public confidence during the Great Depression, stating, "Let me assert my firm belief that the only thing we have to fear is fear itself..." His cabinet appointments included the first woman to a Cabinet post, Secretary of Labor, Frances Perkins.

Birthday - Revolutionary war hero Casimir Pulaski (1747-1779) was born in Poland. Before aiding in the American Revolution, he was a military leader in Poland's struggle against Imperial Russia. He joined the Americans in 1777 and fought alongside General Washington at Brandywine, then served at Germantown and Valley Forge. He was mortally wounded during a heroic

charge in the Siege of Savannah, Georgia.

Birthday - American football legend Knute Rockne (1888-1931) was born in Voss, Norway. He coached the Notre Dame Football team for 13 seasons, amassing an overall record of 105 wins, 12 losses and 5 ties. He became famous for his locker room pep talks and the saying, "Win one for the Gipper." He was killed in an airplane crash on March 31, 1931, in Kansas.

## MARCH 5

March 5, 1933 - Amid a steadily worsening economic situation, newly elected President Franklin D. Roosevelt proclaimed a four-day "Bank Holiday" to stop panic withdrawals by the public and the possible collapse of the American banking system.




March 5, 1946 - The "Iron Curtain" speech was delivered by Winston Churchill at Westminster College in Fulton, Missouri. Churchill used the term to describe the boundary in Europe between free countries of the West and nations of Eastern Europe under Soviet Russia's control.

## MARCH 6



March 6, 1836 - Fort Alamo fell to Mexican troops led by General Santa Anna. The Mexicans had begun the siege of the Texas fort on February 23rd, ending it with the killing of the last defender. "Remember the Alamo" became a rallying cry for Texans who went on to defeat Santa Anna in the Battle of San Jacinto in April.



Birthday - Renaissance genius Michelangelo (1475-1564) was born in Caprese, Italy. He was a painter, sculptor, architect, poet and visionary best known for his fresco on the ceiling of the Sistine Chapel and his sculptures David and The Pieta.

# Afghanistan stun England; knock them out of Champions Trophy

LAHORE (TIP)

Ibrahim Zadran's majestic 177 and pacer Azmatullah Omarzai's fifer trumped Joe Root's masterful hundred, as the brave Afghanistan registered a thrilling 8-run win to knock a largely-insipid England out of the Champions Trophy here on Wednesday, February 26.

England are winless after two matches and in their last league match in Group B they will face South Africa, who already have three points along with Australia.

Afghanistan now have two points and will have to beat the Aussies in their final group match to entertain the hopes of reaching the last four.

For a long time, England's chase merely rattled along as the dismissal of Phil Salt and Jamie Smith jolted them early. They were 30 for two then, and eventually ended up at 317 all out with a ball to spare as pacer Omarzai (5/58) struck at crucial junctures.

But Root (120, 111b, 11x4, 1x6) brought stability to England's innings through two alliances, adding 68 runs with Ben Duckett (38), who was dropped on 29, for the third wicket and then an 83-run stand with skipper Jos Buttler for the fifth wicket.

They were not really blazing partnerships but kept England afloat, keeping them in the vicinity of the asking rate.

But the jettisoning of Duckett and Buttler prematurely curtailed those blossoming joint ventures, as Root had to shoulder the burden all by himself.

Root's was a clever innings, as he hardly hit any ball in anger but still managed a strike-rate close to 100, and at times above 100.

But there were those little flourishes which are so central to a Root innings such as a reverse sweep four off wrist

spinner Noor Ahmad or a scooped six behind wicketkeeper off Fazalhaq Farooqi.

He brought up his 17th ODI hundred with a single off Rashid Khan, and looked to stay on. But a rather tired ramp off pacer Omarzai ended in the gloves of keeper Rahmanullah Gurbaz.

But England had another willing soldier in Jamie Overton (32, 28b), who added precious 54 runs for the seventh wicket, but a feeble heave off Omarzai ended his stint.

It also marked the end of England's

journey in this tournament.

Earlier, Zadran's remarkable innings helped Afghanistan pile 325 for seven.

Zadran, whose hundred came off 146 balls (12x4, 6x6), had solid support from skipper Hashmathullah Shahidi (40, 67b, 3x4), with whom he raised 103 runs for the fourth wicket, and Azmatullah Omarzai (41, 31b) with whom he milked 72 runs for the fifth wicket.

Later, he plundered 111 runs for the sixth wicket with Mohammed Nabi (40, 24b) to put England through the wringer.



## Dhawan reveals Dhoni's key role in Rohit's rise as opener

Former opener Shikhar Dhawan believes Rohit Sharma has matured as a leader over the years and shares a close bond with his teammates, which augurs well for the Indian team.

Dhawan, who was Rohit's opening partner for a considerable period of time, said the Mumbai batter is experienced enough to handle the team.

"From 2013 to 2025, 12 years of experience is a lot. Rohit has been through a lot. He knows how to work in a pressure situation, how to gather the boys.

"As a leader, he has become mature, he knows when to be lenient and when to pull back. It's a fine balance and Rohit's bond with the boys is amazing. We are in a great situation," Dhawan said in a special series titled 'The Shikhar Dhawan Experience' on Star Sports and JioHotstar.

Dhawan also spoke about his 2013 ICC Champions Trophy journey, and recollected his nine-year long opening partnership with Rohit, which also began at the same tournament.

The 39-year-old former left-hander said it was Mahendra Singh Dhoni's idea to promote Rohit as an opener alongside him.

## Champions Trophy: Pakistan's campaign ends on winless note after tie vs Bangladesh called off due to rain

RAWALPINDI (TIP)

Pakistan's campaign in the Champions Trophy ended on a winless note after their match against Bangladesh was called off without a ball being bowled due to incessant rain here on Thursday, February 27.

The match was effectively a dead-rubber, with both teams already out of contention after failing to secure a win in their two previous matches. Pakistan, hosting an ICC tournament for the first time in 29 years, had hoped for a strong finish but ended their disastrous campaign without a victory.

Persistent downpour left the ground soaked, with covers in place and puddles forming around the field. With weather not improving, match officials called off the game nearly two hours after the scheduled start time. The gloomy weather prevented even the toss from taking place.

As a result, the two teams shared one point each,



though both Pakistan and Bangladesh finished the tournament winless.

This is the second match in Rawalpindi to be called

off without a ball being bowled, following the washout between South Africa and Australia earlier this week.

The rain-induced abandonment left the home fans frustrated, as they hoped for play at the Rawalpindi Cricket Stadium.

Pakistan have faced criticism for their poor showing in the tournament, having suffered defeats to New Zealand (by 60 runs) and India (by six wickets).

"We wanted to do well and perform well in front of our nation. The expectations are very high. We didn't perform well and it is disappointing for us," Pakistan captain Mohammad Rizwan said.

Reflecting on the road ahead, Rizwan said: "You can learn from your mistakes. We have made mistakes in the last few games. Hopefully, we can learn from these.

"We are next going to New Zealand and, hopefully, we can perform there and the mistakes that we did against New Zealand here in Pakistan, we can learn from that. And we will do better in New Zealand."
